(usually held the first Thursday of every month). If not in compliance at the end of the 60 days, membership may, at the discretion of the Board of Directors, be terminated. I further understand that only the Board of Directors of the Northeast Oklahoma Board of Realtors® may approve a waiver of this requirement and, failure to attend is cause for dropping me from membership without refund of dues or application fee.

I further agree that my act of paying dues shall evidence my initial and continuing commitment to abide by the aforementioned Code of Ethics, Constitutions, By-Laws, Rules and Regulations, and duty to arbitrate, all as from time to time amended.
