### Agility Rules

#### **Move up Policy:**

Move-ups must be submitted to the Secretary by Monday, May 4, 2020 at 5:00pm. DOS Move-ups will be allowed.

**Refund Policy:** Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from the competition by action of the show committee. Exhibitors are responsible for being at ring side when it is their turn to run.

#### **Entry Eligibility**

1. Lamé dogs, dogs that appear ill, females in season, and pregnant or lactating females may not compete in this trial.
2. No dog that has any sutures, bandages, adhesive or any other visible material indicative of any medical procedure may compete.
3. Dogs must be 6 months of age on the day of the event.
4. An un-entered dog may not be substituted for an entered dog.

**Crating:** All crating will be outdoors. Shade tents are recommended.

### Awards

Qualifying ribbons will be provided for all qualifying runs. Rosettes will be awarded for 1<sup>st</sup> through 4<sup>th</sup> place in each class. Additional Rosettes for High in Trial, High in Trial - Junior, ACH, UACH and GRACH title rosette ribbons.
