Proceedings were aired live on Facebook.

Mayor Gary Davenport called the meeting to order: 7:22 p.m.

A motion to approve the consent agenda was made by Council member Reed and seconded by Council member Stepney. The motion carries (5-0). The consent agenda consist of the following;

Financial reports for November 2021

Minutes of the November 15, 2021 Regular Council Meeting

Mayor Davenport gave an update on the Town's Coronavirus Pandemic situation stating that the number of cases remains high and encouraging everyone to be careful and prayerful. In addition, Mayor Davenport introduced William Scott with Tristatz. A motion to approve the hiring of Tristatz to aid the Town with Federal relief funds as stated in the purposed contract was made by Council member Stepney and seconded by Council member Goodwin. The motion carries (5-0).

Gardner Cameron was present to present his purposed Eagle Scout project at Panther Palace. A motion to approve the project as purposed was made by Council member Goodwin and seconded by Council member Stepney. The motion carries (5-0).

Council member Reed called for an adjustment to the agenda. Mayor Davenport introduced Chris Savage with Kinetic who explained the company's proposal for fiber optic internet service for the Town departments. Council member Stepney asked why the new Sewer facility was not included. Mayor Davenport stated it was not needed at that facility. Assistant Clerk Shannon Duck stated that no changes were made at this time, but could be added as needed. Council member Goodwin inquired as to WIFI service in the Town and was told it would not change. Mayor Davenport told Council this would be a revenue neutral change.

A motion to table the approval of the 2022 Budget until Council can hold a Special Called meeting was made by Council member Stepney and seconded by Council member Goodwin. The motion carries (5-0).

A motion to suspend the rules of consideration was made by Council member Goodwin and seconded by Council member Stepney. Roll Call vote was unanimous. The motion carries (5-0).

A motion to approve the purchase of new Police radios (XG75) in conjunction with Elmore County at a cost of \$28,000.00 to be paid from the Town General fund 2021 retained earnings was made by Council member Goodwin and seconded by Council member Stepney. The motion carries (5-0).

A motion to suspend the rules of consideration was made by Council member Reed and seconded by Council member Mothershed. Roll Call vote was unanimous. The motion carries (5-0).

A motion to approve the purchase of 10 sets of Fire Department turnout gear from the State approved supplier, H-GAC, at a cost of \$31,200.00 to be paid from the Town General fund 2021 retained earnings was made by Council member Goodwin and seconded by Council member Stepney. The motion carries (5-0).

A motion to proceed with joining the Elmore County Commission to negotiate for county wide garbage service was made by Council member Reed and seconded by Council member Stepney. The motion carries (5-0).

Before voting Council member Goodwin inquired as to;
