Specific areas of interest include but are not limited to: cochlear implantation; chronic ear surgery (cholesteatoma, chronic otitis media); acoustic neuroma and other skull base lesions; otosclerosis; facial nerve disorders and tumors; endoscopic ear surgery; implantable hearing aids; and vertigo.

Dr. McRackan has published a comprehensive neurotology textbook and has written over 80 peer-reviewed articles and book chapters. His research interests focus on the development and application of novel measures to evaluate outcomes in individuals with hearing loss and cochlear implants in order to improve patient results.
