Corporate Name

1. The name of the corporation is Seabrook Island Homeowners Association, Inc., referred to as the "Association "

Legal Status

2. The Association is a nonprofit corporation organized pursuant to the Texas Non-Profit Corporation Act.

Duration

3. The period of duration of the Association is perpetual.

Parposes

- 4. The purposes for which the Association is formed are:
- (a) Specifically and primarily to provide an organization to provide for the management, maintenance, preservation, and architectural control of Seabrook Island, a Harris County subdivision, according to the map or plat thereof recorded in Volume 411, Page 56, of the Map Records of Harris County, Texas and all usual and necessary accessories thereto.

(b) Generally:

(1) To promote the health, safety, and welfare of the Owners in Seabrook Island.

- . (2) To exercise all of the powers and privileges and to perform all of the duties and obligations of the Association as set forth in the Declaration of Covenants, Conditions and Restrictions for Seabrook Island and the By-Laws of Seabrook Island Homeowners Association, Inc.
 - (3) To collect assessments as established by the Board of Directors and to pay all office expenses, and all other expenses incidental to the conduct of the business of the Association, including all licenses, taxes, or governmental charges levied or imposed against the property of the Association.
 - (4) To acquire (by purchase or otherwise), own, hold, improve, build on, operate, maintain, convey, sell, lease, transfer, dedicate for public use, or otherwise dispose of real or personal property in connection with the affairs of the Association,
 - (5) To borrow money, mortgage, pledge, deed in trust, or hypothecate any or all of the Association's real or personal property as security for money borrowed or debts incurred.
 - (6) To have and to exercise any and all powers, rights, and privileges that a corporation organized under the Texas Non-Profit Corporation Act by law may now or at a later time have or exercise.
 - (7) To act in the capacity of principal, agent, joint venturer, partner, or otherwise.
- (c) Notwithstanding any of the above statements of purposes, the Association shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purposes of the Association.
