Dwayne VanTassel made a motion, seconded by Todd MacBeth, to close the nominations. With all members voting in the affirmative, IT WAS RESOLVED to appoint Jim Beary as Vice-Chairperson of the Joint Operating Committee for December, 2022 – November, 2023.

Election of Treasurer was not needed due to Jameen Stump, current Treasurer not being elected to another position. Jameen Stump will remain as Treasurer of the Joint Operating Committee until June, 2023.
