	<p>Prior to the meeting Public Question time was held. Three questions were raised.</p> <p>Lack of support from Wiltshire Police and Neighborhood Watch following a burglary in July 2018 in North Wraxall. SW explained that Neighbourhood Watch gathered information for the police and was not a support agency for the public, he suggested that this complaint was taken up with the Police Commissioner for Wiltshire.</p> <p>The Old Coach Road, Ford to North Wraxall. Byway sign has appeared at the N.Wraxall end. Large vehicles are damaging the verges. Request for the Parish Council to find out how wide a byway is and who owns the verges. Clerk to follow up on this.</p> <p>228 Bus route. A copy of a letter sent to Baroness Scott from a Ford resident explained that whilst the 228 bus service picks up at Ford for passengers going to Bath it does not provide a return service and passengers need to either catch a bus or train to Chippenham and then a bus to Bristol to get back to Ford. This resident took a bus to Corsham and then a taxi. Can something be done to get a return service with the 228. Clerk to look into this.</p>
