UPDATE on 12th Annual Seminar and Meeting

It is hard to believe that twelve years has passed since the formation of LAPSWV. I am so proud to have been a member since its inception and have confidence of its continued success and service to its membership.



On June 10, 2016, LAPSWV held its 12th Annual Seminar and Meeting at the Holiday Inn and Suites, Barboursville, West Virginia. The Seminar started at 8:30 a.m. with outstanding presentations from Don O'Dell, Esquire, O'Dell Law/Mediation, PLLC; Susan Lanham, Ph.D., Lanham Economics; Joel Aaron Wright, Realtime Reports; John Huff, Esquire, Jackson Kelly, PLLC; Curtis Wilkerson, Orion Strategies; and Dean Boerger, Boerger Investigative Services, LLC.



During the lunch break, LAPSWV held its 12th Annual Business Meeting. The meeting was called to order at 12:53 p.m. by President Melanie Hicks, ACP. The Minutes of the 11th annual meeting was presented and read. With the exception of three typographical corrections, the minutes were sent to the membership for approval. Sherri Rasmussen made a motion to approve the Minutes, with the corrections, and Jill Francisco, ACP, seconded the motion. There were no objections from the membership and the minutes were approved.

Last came the election of the officers for 2016/2017. Loretta Walker, ACP, Chair of the Nomination Committee, presented the slate of officers to the membership. Ms. Walker advised that Sherri Rasmussen had been nominated as the candidate for the office of President. Ms. Walker made a floor call and no other nominations were made from the floor. Ms. Walker presented Ms. Rasmussen to the membership and called for a vote on the candidate. Ms. Rasmussen was elected as President of LAPSWV for 2016/2017. Ms. Walker then advised that the Nomination Committee did not receive any nominations for the office of First Vice-President. She made a floor call and Melanie Hicks, ACP, nominated Rhonda Swartz, ACP, for the position of First Vice-President. No other nominations were received from the floor and Ms. Walker presented Ms. Swartz to the membership as the candidate for First Vice-President and called for a vote on the candidate. Ms. Swartz was elected as the First Vice-President of LAPSWV. Ms. Walker then announced that Mica Spratt had been nominated as the candidate for Second Vice-President. Ms. Walker made a call to the floor for any additional nominations for Second Vice-President. There being no nominations from the floor, Ms. Walker presented Ms. Spratt as the candidate for Second Vice-President to the membership and called for a vote for the candidate. Ms. Spratt was elected as Second Vice-President. Ms. Walker then advised that the Nomination Committee did not receive any nominations for the Treasurer and made a call for floor nominations. Sherri Rasmussen nominated Kelly Mullins for Treasurer. There being no other floor nominations, Ms. Walker presented Ms. Mullins to the membership as the candidate for Treasurer and called for a vote for the candidate. Ms. Mullins was elected as Treasurer by the membership. Ms. Walker then advised that Donna Hughes had been nominated as the candidate for Secretary. Ms. Walker made a call to the floor for other nominations. There being no nominations from the floor Ms. Walker presented Ms. Hughes as the candidate for Secretary and called for vote for the candidate. Ms. Hughes was elected as the Secretary for LAPSWV. Ms. Walker then advised that Melanie Hicks, ACP, had been nominated for NALA liaison. Ms. Walker made a call to the floor for nominations for NALA Liaison. There being no nominations from the floor, Ms. Walker presented Ms. Hicks as the candidate for NALA Liaison and called for a vote on the candidate. Ms. Hicks was elected as NALA Liaison.



Jill Francisco, ACP, served as the representative from NALA and officiated over the installation of the officers for LAPSWV for 2016/2017. Sherri Rasmussen was affirmed as President; Rhonda Swartz, ACP, was affirmed as First Vice-President; Mica Spratt was affirmed as Second Vice-President; Kelly Mullins was affirmed as Treasurer; Donna Hughes was affirmed as Secretary; and Melanie Hicks was affirmed as NALA Liaison for LAPSWV for the 2016/2017 fiscal year.

The 12th Annual Meeting closed at 1:30 p.m. with a motion from Loretta Walker, ACP to end the meeting. Patricia Schoolcraft, CLA, seconded the motion. There being no objections from the floor, the meeting ended.





NALA In Vegas

However, I have to share what happens at a NALA Convention in Vegas! Each day began with a morning yoga stretch to jump start a day of education. The first day kicked off the excitement with keynote speaker, Honorable Judge Jackie Glass (Ret.). Judge Glass retired was a litigating attorney in Las Vegas until being elected to Nevada's Eighth Judicial Circuit Court in 2002. She was the presiding Judge in the armed robbery and kidnapping charges against O. J. Simpson in 2008. Judge Glass then retired from the bench and replaced Nancy Grace on the television series "Swift Justice". Her experiences in the courtroom have been extraordinary and she shared many of those experiences with us.



The educational opportunities at this convention were structured differently than in past years. Attendees could choose from different topics by session instead of choosing one tract for the entirety of the convention. The session topics included: Sports Litigation, Legal Aspects of a Feature Film, Technology and Ethics, Essential Skills, Intellectual Property Crimes and many more. The options allow each attendee to learn about areas of the legal field they work in or explore new areas of the legal field. One of the best educational opportunities is to

attend sessions in the Essential Skills tract taught by Virginia Koerselman. Mrs. Koerselman is the author of the NALA Certified Paralegal Study Guide. This is a great opportunity for anyone who is preparing for the certifying exam!



The All Conference Luncheon is always a great event to attend. The food was great this year! Each year NALA chooses a charitable organization to support by collecting donations during the convention. The organization chosen this year was Three Square. During the All Conference Luncheon, representatives of Threes Square spoke to attendees about their organization's mission "to provide wholesome food to hungry people, while passionately pursuing a hunger-free community". NALA conference attendees donated \$4,354 for the organization which will provide 13,062 meals to hungry people.

There are always great vendors to meet at the convention. It is a great source of contacts for services you may need in your area of the legal field. How great is it when an attorney says I need to find a court reporting service for depositions in California – and you have contact information for a national court reporting service? Perks of going to NALA convention! Affiliated Associations also set up booths to promote their organizations. Seeing what other organizations are doing successfully provides new ideas for our local organization. There are always great give-away items too!

NALA has leadership program called LEAP in which participants commit to a year-long program to learn how to become better leaders in their career, organizations and personal life. I participated in the program several years ago and am now a mentor for LEAP as part of the Professional Development Committee. This year the "LEAPsters" presented individual projects that were displayed for attendees to view. It was a lot of fun to see each project and hear about each person's experience. I encourage everyone to explore the opportunities available through LEAP and other NALA programs!



All the great opportunities are enhanced by the comradery and friendship found with other paralegals at NALA conventions. I got to meet a paralegal who works with the Native American Tribal Counsel which I learned is a separate legal system with very specific jurisdiction. I spent time with paralegals from Maryland, Alabama, Tennessee, Michigan and Oklahoma. Although there are some things that will stay in Vegas the experience of the NALA convention stays with you throughout all you do. 
