# **Other Business:**

- Evan Brasseur, a town resident, joined the meeting to review an idea he had regarding the Town Forest. He would like to gain access to the town forest to do projects, in conjunction with the Lowell Graded School, with the students. He wants to start a summer program that would involve exploring and mapping of the town forest. He has established his own mapping company, and in order to maintain his license he has to perform some type of community service. He noted he had a successful experience doing this with another school in Vermont and would love to bring the program to the Lowell graded school. He has already spoken to Anita Gagner, Lowell Graded School Principle, and she has given Evan Permission to start the Program in the summer. Evan then asked the Board if he could have permission to access the Town forest to pursue the mapping program for the kids at Lowell Graded School. He would also like to pursue looking into doing the mapping for The Bailey Hazen Military Road and teach the students some history on this road, as well. The Board felt it was a fine idea and gave Evan permission to do so. Evan also asked permission to explore the Town Forest on his own before starting his proposed project with the students in the summer. The Board gave him permission to do this as well.
