SITE EVALUATION APPLICATION

According to the Ohio Administrative Code a site evaluation and permit to install must be purchased prior to the installation of an on-site sewage disposal system or the construction of any new residential dwelling.

Steps for Obtaining a Site Evaluation and Permit to Install

1) Complete and return attached site evaluation application and the associated inspection fee. **The site evaluation fee for a new installation is \$300.00 and for a repair installation is \$100.00.** In addition, a copy of the deed or land contract, survey/ plot map of the property and a floor plan of the proposed home must be submitted at the time of application. **All required paperwork and fees must be submitted prior to an inspection being scheduled or conducted.** The site evaluation will be conducted in a timely manner, but may, depending on scheduling and limited personnel may take up to two weeks to occur. Adams County requires that all proposed development sites contain a minimum of one acre of usable ground for approval unless originally platted prior to 1994.

2) The proposed development site must be ready for an inspection prior to submitting this application, a sign with the address or owners name need to be placed along the roadway for easy identification of the site and the home site needs to be identified with four corner markers showing the homes location. **If we are unable to locate the site or the site location changes after the site evaluation has been conducted a re-inspection fee of \$100.00 will assessed.**

No land clearing, bulldozing, or construction shall occur prior to the site evaluation being conducted. A penalty fee of two times the total fees will be assessed if these activities have occurred prior to the inspection. No part of the septic system shall be installed until a site approval has been given and a permit to install purchased. The installation of a septic system without a permit to install will result in a penalty of 2 ½ times the permit fee plus the permit fee. The homeowner is responsible for ensuring that all evaluations and permits are purchased prior to starting any work.

3) After the site has been inspected by our staff and advised that the property is developable, you will need to contract with a Soil Scientist, at the owners' expense, to have the soils on the property evaluated. You will receive a report from the Soil Scientist describing the soil conditions of your property. This report will need to be submitted to our office for the design of your onsite sewage treatment system. **This approval is valid for five years from the date of signature.**

4) Only licensed and bonded septic system installers are permitted to install on-site sewage disposal systems in Adams County. Attached is a list of those installers that are registered to install or repair septic systems in our county. Prior to obtaining your permit to install you will need to know which contractor will be installing your system.

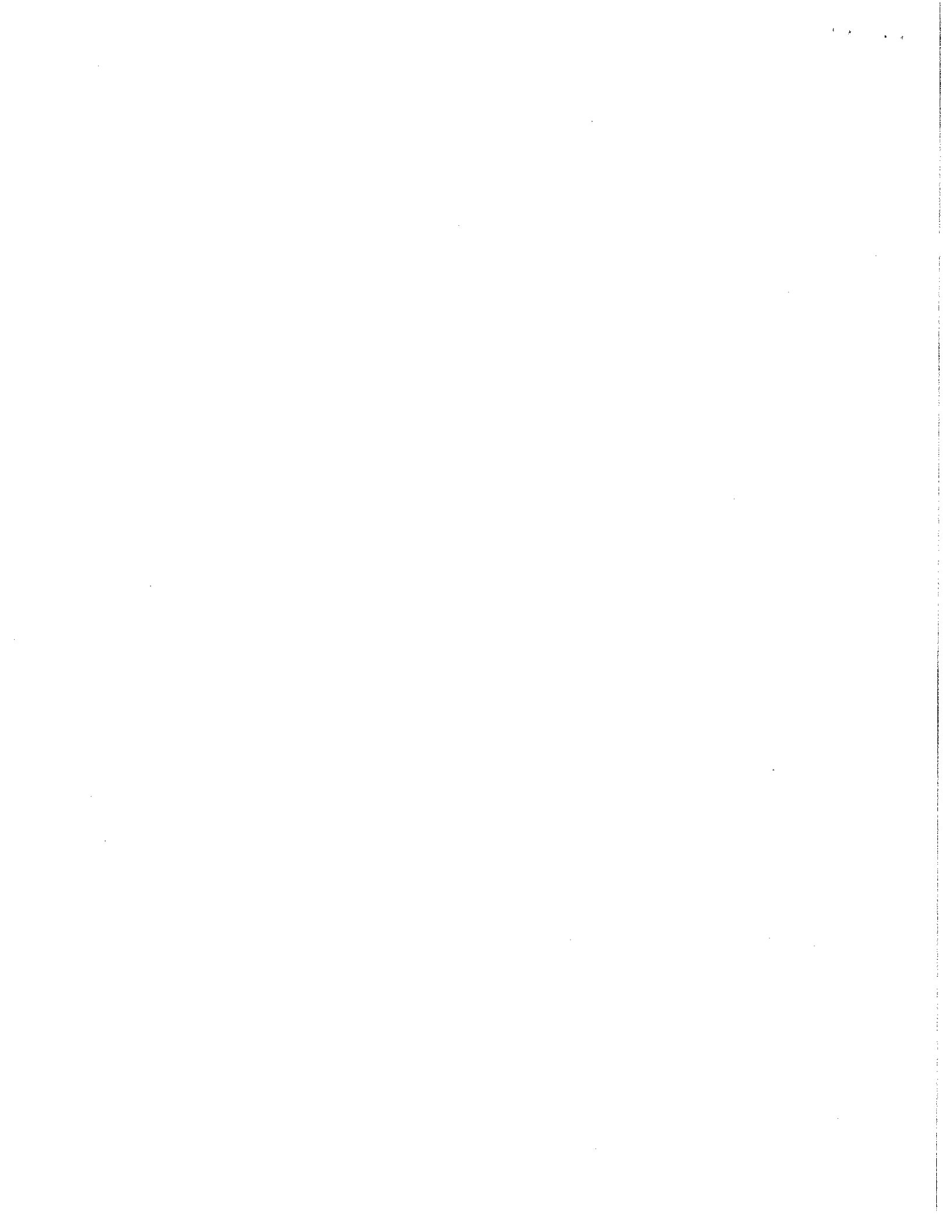
