2015-2016 NEWSLETTER

Dear Fellow Members.

The board would like to bring you up to date on club news from 2014-2015. The club hosted several successful events in 2014 including: The fall and winter rendezvous, two outdoor 3-D archery shoots, two indoor 3-D archery shoots. We hosted a Vegas 300/450 Round, the 3rd Annual Women's Fun shoot and The 22 Long Rifle competition for adults and youth. A new electronic gate and key card system was installed in March along with the road was widened 10' for easier access to the electronic key card system. A new concrete side walk was installed on the south and east end of the Indoor building and a new concrete floor was poured in the garage along with new underground wiring and lighting. We added a new steel roof and siding on the old club house. Improvements were made to the 200 Yard Range, which included installing bunker block along the 200 range for added safety, installing new steel gates and dumping crushed rock along the 200 yard backstops for Firearms Safety classes and other firearm training. We installed a used air conditioner in the indoor building. Also, we purchased Archery bags for the outdoor range and an additional 10 dz arrows for the youth archery classes. The club had 102 kids from ages 6-17 participate in Beginning and Advanced archery classes in 2014. The club also hosted firearms safety training, personal protection training, FCI, OPD, Steele County Sheriff's office and SWAT team range qualification. The club donated \$10,000.00 to the Owatonna Foundation.

Future plans are to build a new canopy and chain link fence for the rendezvous to store firewood, epoxy the concrete floor of the indoor building, and install new steel soffits on the old club house along with new steel roofs on the 50& 100 yd. canopy's. We also plan to install more security cameras and donate to Owatonna Foundation and other non-profit organizations.

Monthly meetings start at 7:30 pm. The Waiver Agreement fee remains at <u>\$10.00</u> for 2015-2016. The club appreciates your contributions to help improve the club facilities to keep The 20 Rifle & Pistol Club a safer place to shoot for all its members.

The club has a number of new scheduled events for the 2015/2016 year. Check the calendar on the website for all special events and for range closings. The club continues to look for ways to assist the local school district with educational materials and lecture programs that will expose students to club related topics. The club is also planning several Work Days depending on weather to be announced at a later date. Your help and involvement through out the coming year will be appreciated.
