Minutes of October 4, 2021

The Huntington Township Trustees met in regular scheduled session at 7:00 PM at the Township Hall. Meeting called to order with the pledge of Allegiance by Robert Holmes. Also present were Walter Rollin, Jed Lamb, Matt Combs, Dimitri Szynal, Frances Rollin and Sheila Lanning. *Motion* by Lamb with a second by Rollin to approve the minutes of the regular scheduled meeting of September 20, 2021 as written. Roll call: three yeas. Checks 9687-9700 and payments totaling \$14,908.44 approved for payment. *Motion* by Lamb with a second by Rollin to approve the September financial reports showing year to date revenue of \$525,050.36, year to date expenditures of \$381,853.22 and bank balances of \$450,766.11. Roll call: three yeas. *Motion* by Rollin with a second by Holmes to authorize the payment listing as presented. Roll call: three yeas. *Motion* by Holmes with a second by Lamb to authorize *Resolution 2021-48* to amend appropriations as presented. Roll call: three yeas. *Motion* by Lamb with a second by Rollin to authorize *Resolution 2021-49* accepting the amounts and rates as determined by the Budget Commission and authorizing the necessary tax levies and certifying them to the county auditor. Roll call: three yeas.

WATER BOARD- Lamb: meeting next week.

LORCO- Lamb: meeting next week. Lanning: email from Mr. Toy on American Rescue Plan grant money and LORCO's application for Cinnamon Lake through the ARP.

AMBULANCE- Holmes: meeting 10/12 @8:00

SHERIFF- Holmes: will contact Findley State Park about the noise complaints called into the Sheriff. **FIRE**- Rollin: meeting Wednesday, chili cook off is 11/4/2021 @ Eagles with proceeds to Well Help. **SWAC**- Lanning: requests for reimbursement of two grants sent.

ZONING BUSINESS/NEWS- Lanning: Zoning Commission working to update zoning for Ponds. **THRIVE & OFFICE ON AGING-** Rollin: meeting location changed, unable to attend.

CEMETERY- Lanning: Sexton family asking to have bricklayer's union members construct monument. Ashland monument to make an insert for the monument. Discussion on height/size of constructed monument.
