6. Action to approve Order No. 23091406 of the Bexar County Emergency Services District No 10. Levying the ad valorem taxes for the 2023 Tax Year at a rate of \$0.10 per \$100.00 assessed valuation on all taxable property within the legally established boundaries of Bexar County Emergency Services District No. 10 to provide revenue for maintenance and operations needs for 2023 - 2024 fiscal year: and at a rate of \$0.00 (zero) per \$100.00 assessed valuation on all taxable property within the legally established boundaries of Bexar County Emergency Services District No. 10 to provide revenue for debt services needs for 2023 - 2024 fiscal year. THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEARS'S RATE. THE TAX RATE WILL EFFECTIVELY BE RAISED BY 11.30 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON \$188,826 AVERAGE HOMESTEAD BY APPROXIMATELY \$19.75.
