RACE INFO: Join us Saturday July 29th for the 3rd Annual Dakota Matz 5k Fitness Challenge and walk, a 5k with a twist. The course consists mostly of roads, sidewalks, and paved trails surrounding Zanes Landing Park. The challenge requires completion of three stations throughout the duration of the race. Stations are a surprise this year-be ready for anything and embrace the unknown.
