KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, by that certain instrument dated November 15, 1974, and designated as "Declaration of Covenants, Conditions and Restrictions", executed by U.S. Home Corporation of Texas, as Declarant, recorded at Volume 632, Page 713, of the Deed Records of Fort Bend County, Texas, (hereinafter referred to as "Said Declaration"), those certain tracts and parcels of land therein described and known as TOWNEMEST, SECTION ONE, (hereinafter referred to as "Section One"), were encumbered and subjected to said Declaration, to which said Declaration reference is here made for more particular description and all other pertinent purposes; and

Annexation of additional properties, conveyance and/or dedication of Common Area, Amendment of this Declaration of Coverants, Conditions and Restrictions, Mergers and Consolidations, Mortgaging of the Common Area, and Management Agreements.
