INDEMNIFICATION, HOLD HARMLESS, AND RELEASE FOR FAMILY LIFE CENTER'S WALK A MILE IN HER SHOES® EVENT 2019

I, the undersigned individual, on behalf of myself and all walkers, of all ages, in the Named Group (if applicable), desire to participate in the Family Life Center's Walk A Mile In Her Shoes® Event 2019. I/we acknowledge that the event is a test of a person's physical and mental limits and it carries with it potential for death, serious injury, and property loss. I/WE HEREBY ASSUME THE RISKS OF PARTICIPATING IN THE FAMILY LIFE CENTER'S WALK A MILE IN HER SHOES® EVENT. I/we certify that I/we am/are physically fit, have sufficiently trained for participation in this event, and have not been advised otherwise by a qualified health professional. I/we hereby take the following action for myself/ourselves, my/our executors, administrators, heirs, next of kin, successors and assigns, or anyone else who might claim or sue on my/our behalf and I/we expressly acknowledge that it is my/our intent to take these actions. I/we hereby: (a) AGREE to abide by the competitive rules adopted by Family Life Center and Walk A Mile In Her Shoes®; (b) AGREE that prior to participating in this event, I/we will inspect the walk course, facilities, equipment, and areas to be used and if I/we believe any to be unsafe I/we will advise the person supervising this event, activity, facility, or area; (c) WAIVE, RELEASE, AND DISCHARGE FROM ANY AND ALL CLAIMS, LOSSES, OR LIABILITIES FOR DEATH, PERSONAL INJURY, PARTIAL OR PERMANENT DISABILITY, PROPERTY DAMAGE, MEDICAL OR HOSPITAL BILLS, THEFT OR DAMAGES OF ANY KIND, INCLUDING ECONOMIC LOSSES AND LOST OR STOLEN ITEMS, WHICH ARISE OUT OF OR RELATED TO MY/OUR PARTICIPATION IN, OR MY/OUR TRAVELING TO AND FROM THE EVENT, FAMILY LIFE CENTER, THE CITY OF FLAGLER BEACH, THEIR EMPLOYEES, VOLUNTEERS, AND AGENTS, EVEN IF SUCH CLAIMS, LOSSES OR LIABILITIES ARE CAUSED BY THE NEGLIGENT ACTS OR OMISSIONS OF THE PERSONS I/WE AM HEREBY RELEASING OR ARE CAUSED BY NEGLIGENT ACTS OF ANY OTHER PERSON OR ENTITY; (d) ACKNOWLEDGE that there will be both human and motor vehicle traffic on the course route; (e) ASSUME THE RISKS OF WALKING AND PARTICIPATING IN THIS EVENT; (f) ASSUME ANY AND ALL OTHER RISKS associated with participating in this event, including but not limited to, falls, contact or crashes with others event participants or any other pedestrian, weather - including heat or humidity, defective equipment, the condition of the sidewalks and/or roads, water hazards, and/or any hazard that may be posed by spectators or volunteers, all such risks being known and appreciated by me/us, and I/we further acknowledge that these risks include risks that may be the negligence of the persons or entities mentioned in paragraph (c) or other persons or entities; (g) AGREE NOT TO SUE ANY OF THE PERSONS OR ENTITIES MENTIONED ABOVE IN PARAGRAPH (c) for any of the claims, losses or liabilities that I/we have waived, released or discharged herein; (h) INDEMNIFY AND HOLD HARMLESS THE PERSONS AND ENTITIES MENTIONED IN PARAGRAPH (c) for any and all claims made or liabilities assessed against them as a result of my/our actions or inactions; (i) GRANT PERMISSION for the use of my/our name(s) and/or likeness(es) relating to my/our participation in the FAMILY LIFE CENTER WALK A MILE IN HER SHOES® EVENT 2019, and I/we waive all rights to any future compensation to which I may otherwise be entitled as a result of the use of my/our likeness(es) by Family Life Center or the City of Flagler Beach; (j) UNDERSTAND and accept that my/our entry fee is non-refundable under any circumstances; (k) AFFIRM THAT I/WE AM/ARE EIGHTEEN (18) YEARS OF AGE OR OLDER, AND/OR HAVE PERMISSION FROM THE PARENT(S)/GUARDIAN(S) OF EACH PERSON IN THE NAMED GROUP WHO IS UNDER 18 YEARS OF AGE TO SPEAK/SIGN/ACT ON THEIR BEHALF, AND THAT I/WE HAVE READ THIS DOCUMENT AND UNDERSTAND ITS CONTENTS; and (l) give permission to Family Life Center and the City of Flagler Beach to take photographs and video recordings of me/us, all other individuals walking with the named Group, my/our child(ren), and my (our) family members, while participating in the event, and further agree that Family Life Center and/or the City of Flagler Beach may use walkers' names, faces, likenesses, voices and appearances in connection with exhibitions, publicity, advertising, and commercial materials, without reservation or limitation, in print, on the Family Life Center and/or City websites, and/or other broadcast and/or media.
