The Thomas Creek FSC offers a bridge program to skaters who have passed their basic skills 5 and wish to **transition** through the USFS Freeskate badges and **into the Club**. The role of the bridge program is to teach skating skills at a faster pace in a group lesson and to introduce the skaters and parents to the benefits of club membership. Participants will be a club member or a current basic skills member (basic skills members must provide a current USFS card confirming their membership).

In addition to skating skills other items of necessity will be broached such as: proper stretching techniques, warm up and cool downs, stroking, ice etiquette and most importantly ice safety.

As the name suggests - BRIDGE- this program was designed to bridge the gap between Basic skills and membership into the Club. With that said, the Bridge program will be offered to qualifying skaters (club members, current basic skills members who have passed level 5 with proof of basic skills membership). The Thomas Creek Figure Skating Board highly recommends that skaters participate in bridge no longer than 4 sessions and then participate in Club membership and club ice.
