## **ADD/ADHD Management Protocol**

## TOVA testing

- o Patients up to 15 years old will need testing every 6 months
  - One (1) test while on medications (*meds taken 2 hours before testing*)
  - One (1) test while off medications
  - If patient prescription is unstable, further testing and monthly follow-ups may be required
- o Patients 15 years old and older will need testing once a year
  - One (1) test while on medications (*meds taken 2 hours before testing*)
  - One (1) test while off medications
  - If patient prescription is unstable, further testing and monthly follow-ups may be required
- Monthly Prescription Management appointments
  - This time will be used to document stability and progress on the prescription's current dose, discuss adjustments needed and other diagnosis-specific issues.
  - Parents/guardians with multiple children under this care will only need to schedule a single appointment prior to refills. Review/evaluation for all children needing refills will be taken care of at that single appointment.
  - If child's prescription is NOT stable (current dose needs adjustment), the child will need to be present.
  - o If child's prescription is stable (current dose is working), the child will not have to be present.

## • <u>Stable prescription patients</u>: Monthly appointments NOT NECESSARY for 6 months

- o Complete 2 TOVA tests (without medication(s) dosage changes) and 3-month prescription will be issued
- After 3-months of prescriptions are used, <u>send patient portal message</u> for additional 3-months of refills (no appointment needed unless child's prescription dosage is changed).
- Before 6-months of prescriptions are used:
  - Complete 2 TOVA tests to determine if child can maintain Stable schedule
  - 1 week prior to need of refill, schedule an appointment with Leigh Ann.
- o Patients 15 years and older will need an appointment at 6-months to discuss stability of medication

## • Unstable prescription patients: Monthly appointments NECESSARY

- o Complete 2 TOVA tests (or more as needed to dial in the prescription).
- Monthly prescription management appointments needed (issue of 1-month prescription at a time).
- Once prescription is stabilized, patient will fall under "Stable prescription patient".
- Complete annual well-child exam
- Medications will not be refilled if protocol is not followed.

The State of Texas monitors Triplicate medications and we must follow certain guidelines. To assist us in processing these prescriptions, please note the following instructions:

- Allow <u>5 business days</u> for refills to be processed
- Prescriptions can be mailed to you via certified mail, which will cost you \$8/mailing.
- Prescriptions expire in 21 days. If it expires before refill, there is a \$10 rewrite fee and expired prescription must be returned to office.
- If a prescription is lost, there will be a \$15 fee and the lost prescription form must be completed before the medication can be refilled.
