- 2. To consider * planning decision notifications from Kirklees Council 2011/90157 Track off Hopton Lane Cllr Lees-Hamilton gave brief history of the application
- 3. Mirfield Moor No Update
- 4. Proposed development Balderstone Hall Lane Cllr K Taylor tells MTC of the installation of 2 cameras on Wellhouse Lane. Through investigation it transpires that these are traffic monitoring video cameras operating for 2 days from 8.00am till 4.30pm on behalf of Bellway Homes. It appears that neither the local Primary School nor residents have been informed of this. Clir Taylor confirms that she spoke to Kirklees, who also had no knowledge of the cameras. Cllr Lees-Hamilton states that it is the norm to use the speed loops and that if MTC are not happy with Bellway's results that MTC will ask Kirklees to do a traffic count. Cllr Bolt states that under SPD1 developers must make a £7k contribution to highways improvements if 10 or more peak trips are generated from a development. Cllr J Taylor reads an article from 13/1/14 Daily Telegraph regarding development without council decisions. Cllrs Pinder, Lees-Hamilton & K Taylor show concern for possible land banking by developers and banks. Cllr Lees-Hamilton briefly explains land banking to Cllrs. Cllr Bolt Proposed that MTC invite MP S Reevell to a meeting to discuss planning and intentions regarding planning at Westminster Cllr Lees-Hamilton Seconded Vote: All in favour Clir J Taylor commented that at the recent 'Save Mirfield' meeting MP S Reevell had commented that it was the best attended meeting he had been to and that he would do all he could to help 'Save Mirfield' and Mirfield Town Council.

- 1. Mirfield Public Toilets Cllr Pinder confirmed he had appointed Adam Cockcroft from Ramsdens Solicitors Huddersfield in respect of the lease. He confirmed that there were a few points to look at but was looking at a time frame of 28th January meeting to present the lease for consideration and approval. Cllr Armitage asked if this could be seen prior to the meeting Cllr Pinder confirmed he would circulate prior to 28th January.
- 2. Clearance of Mirfield Towpath Cllr Nottingham informed Council that he was holding another Towpath clearing event on Saturday 8th March 10am-12pm @ Shepley Marina. The Rotary Club will be attending and Cllr Mapplebeck has offered the use of his barge to help clean the water and refreshments will be provided at the Navigation Tavern.
- 3. Health & Safety Paperboys/girls Cllr Lees-Hamilton stated that Newsagents needed to raise awareness of this legal requirement and explained in brief what had been omitted prior to the death of Declan. She would like to extend an invite for the first meeting in

February to all Newsagents to discuss this. Cllrs are unsure of the Health & Safety requirements, Cllr Lees-Hamilton confirms that she will email this to them. Cllr Bolt agrees that MTC should invite local newsagents and The Federation of Retail Newsagents to a meeting.
