Checks should be made out to: SLM Dressage. A full refund minus the office fee will be refunded if management is notified of a scratch before the show closing date. After the show closing date there will be no refunds for any reason including acts of God.

Awards: First place will receive a prize, other prizes may be awarded at managements discretion

Tentative Schedule of classes: Tests at the highest level will be done at the beginning of the show. We will proceed from the highest level to the lowest level throughout the day. Some levels may be intermixed to allow sufficient time for horse and rider to have a break between tests. Musical Freestyles will run close to lunch time. The Exceptional Rider Division will be run in the afternoon.

Ribbons will be awarded by division 1st-6th place per division, per class. Ties will be broken by the test with the higher total collective marks for that test. If both tests have the same total collective marks, the tie will remain.

Footing: Competition ring is 215'x80' sand/stone dust mixture, warm up is in the indoor arena with sand/rubber mixture.

Headgear Statement: An exhibitor cannot be penalized for wearing protective headgear. (GR801).

USEF Membership Statement:

Eventing Competitions at the Modified Level or above, Combined Driving Competitions at the Advanced Level, Dressage Competitions, Endurance Rides and Vaulting Competitions: (See GR828.4 of the Federation rules). Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, or agent, at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the followin g classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4 H members; 5) walk trot (exception: Friesian performance FR231) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes

WDAA Membership Statement:

To be eligible to participate and/or compete as an exhibitor, owner, lessee, agent, coach, or trainer in any Western Dressage class or at any Western Dressage Federation Licensed Competition persons must be active members of WDAA or pay a non-member fee equal to the price of an annual membership for each competition

Exceptional Rider Division – (Exhibition only, not USEF regulated)

- Physically Challenged classes (use standard WDAA tests) Open to individuals with a diagnosed significant physical disability. A **WDAA Statement of Eligibility for Exceptional Rider Classes** form is required to show in these classes.
- Therapeutic Rider classes (use WDAA Therapeutic Rider tests) Open to individuals with a diagnosed physical, social, or emotional disability. A **WDAA Statement of Eligibility for Exceptional Rider Classes** form is required to show in these classes.

Horses and riders entered only in the Exceptional Rider Division are exempt from USEF membership requirements, and do not have to pay non-member (show pass). Federation and drug fees do not apply. Horses entered only in these classes are still subject to and must comply with the Drugs and Medication rules and are subject to drug testing. Participants must abide by all USEF regulations pertaining to attire, tack, and equipment for the recognized show.

Reference GR120 for additional information. Exceptional riders may not cross enter between Physically Challenged and Therapeutic classes.

Competitors Freestyle Reminders:

- Upload your music with your entry on Horseshowoffice.com clearly labeled with your name, horse's name, and freestyle level (no not use special characters or symbols).
- Be present for your sound check.
- Know the rules for the level you are riding. This includes forbidden and allowed movements for your level.

Motorized Vehicle Statement:

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, licensed competitions. Minors scooters, or farm utility vehicles, on the competition grounds of who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. parent/legal guardian or individual who signs the entry The blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible actions resulting from that operation. V for any damages, claims, losses or violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance individuals with disabilities are exempt from this rule. The unsafe use of personal devices for electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited Operating such devices in areas on competition grounds. where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device the entry blank as a pa is a minor, the parent/legal guardian or individual who signs rent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other individuals with disabilities are exempt from this rule.

SafeSport: Reminder: All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must

adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at www.usef.org.

From NJ Turnpike: Take Exit 5 (Burlington, Mt Holly, Westampton). At the light make a right onto Burlington-Mt. Holly Road. Make a slight right onto the jug handle for Burrs Road. Take Burrs Road to Oxmead Road and make a right onto Oxmead Road. Make your first right onto Kings Road. 150 will be .5 miles on the right. Turn into the second entrance.

From 295: Take exit 47A onto Burlington-Mt. Holly Road. After the first traffic light, make a slight right onto the jug handle for Bromley Blvd. Take Bromely Blvd to Oxmead Road and make a right. Take Oxmead Road to Kings Road and make a right. 150 is .5 miles up on the right. Turn into the second entrance.

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and ("USEF Event" or "USEF Events"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors,, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

A. RULES AND REGULATIONS: I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at www.usef.org, as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

EQUINE ACTIVITY LIABILITY ACT WARNING:

WAIVER AND RELEASE OF LIABILITY, HOLD HARMLESS AND INDEMNITY: In conjunction with my participation in any USEF Event, I hereby release, waive and covenant not to sue, and further agree to indemnify, defend and hold harmless the following parties: USEF, USEF Recognized Affiliate Associations, the United States Olympic & Paralympic Committee (USOPC), USEF clubs, members, Event participants (including athletes/riders, coaches, trainers, judges/officials, and other personnel), the Event owner, licensee, and competition managers; the promoters, sponsors, or advertisers of any USEF Event; any charity or other beneficiary which may benefit from the USEF Event; the owners, managers, or lessors of any facilities or premises where a USEF Event may be held; and all directors, officers, employees, agents, contractors, and volunteers of any of the aforementioned parties (Individually and Collectively, the "Released Parties" or "Event Organizers"), with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss, or expense (including court costs and reasonable attorney fees) of any kind or nature ("Liability") which may arise out of, result from, or relate in any way to my participation in the USEF Events, including claims for Liability caused in whole or in part by the negligent acts or omissions of the Released Parties.
