## **EMERGENCY SOLUTIONS GRANT (ESG)**

### **RAPID RE-HOUSING PROGRAM**

Funding through the Illinois Department of Human Services (IDHS) to assist homeless individuals and families to gain or maintain housing.

- Must be homeless.
- Must fall into one of the categories under homeless definition:
  - Staying in Emergency Shelter, Safe Haven, Motel/Hotel supported with Government/Charity, Street/Place not meant for human habitation; Fleeing/attempting to flee Domestic Violence.
- Rent must be under Fair Market Rent Amount.
- Must have no appropriate subsequent housing options.
- Must lack sufficient resources and support networks to retain housing.

### **HOMELESS PREVENTION PROGRAM**

Funding provided through the Illinois Department of Human Services (IDHS) to assist individuals and families with one-time assistance with rent/deposit or mortgage assistance to prevent homelessness.

- Income under 200% Poverty
- Proven financial crisis within the last 90 days
- One-time assistance
- Rent must be affordable no more than 50% of NET income
- Must not have received help in the last 2 years
- Lack financial resources to prevent homelessness without assistance

## **VOUCHER SHELTER**

Funding provided through the Illinois Department of Human Services (IDHS) to assist individuals with voucher shelter in an emergency situation to prevent homelessness.

- Income under 200% poverty level.
- Must be literally homeless and unable to stay at a homeless shelter.
- Must lack financial resources to obtain shelter on their own.
- Must not have received help in the last 2 years.



### **RENTAL HOUSING SUPPORT PROGRAM**

Funding provided through the Illinois Housing Development Authority (IHDA) and Illinois Association of Community Action Agencies (IACAA) to provide subsidies to landlords that will make housing units affordable to extremely low and severely low income households.

- Income at or below the 30% of area median income.
- First come, first served basis as units are available.
