

MINUTES OF RHE MEETING OF JAN. 14, 1994

MEETING CONVENED AT 8:35 P.M. VICE COMMANDER TONY CIATOLA PRESIDING. 22 MEMBERS PRESENT.

MINUTES OF PREVIOUS MEETING WERE ACCEPTED AS READ.

COMITTEE REPORTS

MEMBERSHIP-CHARLIE FONTANA SAID MEMBESHIP RENEWALS IS IN GOOD SHAPE AND WE ARE NEAR OUR GOAL OF 100%.

POST ACTIVITIES-CHARLIE FONTANA STATED THAT THE NEW YEAR'S EVE PARTY WAS VERY SUCCESSFUL. A \$200 PROFIT WAS MADE AND THAT THERE WAS A LOT OF BEER, SODA AND FOOD LEFT OVER AND WILL BE USED AT POST MEETINGS.

POST EDITOR- RICHIE REICHART SAID HE EXPECTED THE NEXT EDITION OF THE POST PAPER TO GO TO PRESS NEXT WEEK.

HONOR GUARD-RICHIE REICHART REPORTED THAT THE COUNTY WILL ASSIST MEMBERS FROM OUR POST AND OTHER POST TO OBTAIN HONOR GUARD MATERIAL FOR THOSE PEOPLE WHO WILL PARTICIPATE IN COUNTY ACTIVITIES.

TREASURER-PAT MESERIDINO REPORTED THAT INCOME SINCE THE LAST REPORT WAS \$3434 AND EXPENSES WER \$4226. THIS WAS A REDUCTION OF \$792 LEAVING A BALANCE IN THE POST TREASURY OF \$422.71.

LOUNGE-GARY JAFFEE GAVE A FINANCIAL REPORT COVERING NOVEMBER AND DECEMBER. INCOME WAS \$592 AND EXPENSES WERE \$565 RESULTING IN A PROFIT OT \$26. THE BALANCE IN THE REPLACING FUND IS NOW \$216. GARY ALSO ANNOUNCE THAT THERE WILL BE A SUPERBOWL PARTY ON JAN. 30. THE PRICE WILL BE \$15 PER PERSON AND WILL INCLUDE AN OPEN BAR, HOT AND COLD FOOD TO BE SERVED PRIOR TO THE GAME. ALSO THERE WILL A FOOTBALL POOL AND BOXES WILL BE SOLD AT \$2, BOX HOLDERS NEED NOT BE PRESENT TO WIN.

MIKE SHANE REPORTED THAT VINNY ZANGARI WAS NOT FEELING WELL AND HAS NOT BEEN OUT THE HOUSE FOR THE PAST TEN DAYS.
