Fire Chief Golden will be submitting a proposal to Madison Township for fire services. Fire Chief Golden reported he will be submitting for a contractor to write a grant for Hocking Township for a new fire truck. He also received an email from Lancaster about Hocking Township not being able to fill their trucks from the hydrants. Fire Chief Golden will follow up on this.

#### **OLD BUSINESS:**

- Country Club Road has been paved and the bond can be released. Trustee Ellinger
