Please understand the following:

1. *As a judge, you will see only those teams that you are judging. You will NOT be judging your own child's team, and you will NOT be able to leave your judging position to see any other team perform.*
2. *Only TRAINED judges can serve at the tournament. If you are unable to complete the training, please notify your team's coach or school coordinator immediately, so they can seek a replacement.*
3. *You MUST **complete** your online registration by JANUARY 10. The team canNOT be scheduled to compete until you do. You will receive an email with a link to the national registration site. Please answer all questions honestly and completely.*
4. *You will receive your judging assignment via email approximately the last week in January. Please mark the training and tournament dates on your calendar.*
5. *Any team who does not provide a **2022-TRAINED** judge for the tournament **WILL** be assessed a 25 point administrative penalty and may be fined up to \$100.*
6. *If you request to judge in a particular problem, please know that every effort will be made to place you on a judging team in that problem, but sometimes it's not possible to do so. Please look for and read the email that will notify you of your assignment. A copy of the problem you'll be judging and other important information will be attached.*
