SECTION 3: AGREEMENT AND CERTIFICATION

I understand that as a volunteer, I will receive no pay and will not be covered under any insurance regarding any possible injury while volunteering at Purrfect Pets or for the benefit of Purrfect Pets at any location. I understand and acknowledge that the animals involved in Purrfect Pets' program may be scared or unhealthy, and Purrfect Pets makes no representations whatsoever regarding the animal's temperament, health (including the presence or absence of diseases transmissible to humans or to other animals), age, ability, attitude, or socialability.

I assume all risks relating to working with the Purrfect Pets animals. I release Purrfect Pets, its officers, directors, participants, volunteers, and affiliates from any and all claims, actions, liabilities, damages, and costs of any kind ("claims" and "costs") arising out of transportation, fostering, or any other work or activity with any animal connected with Purrfect Pets. If anyone in my household makes a claim, I will indemnify, defend, and hold Purrfect Pets and Purrfect Pets participants harmless from such claims and costs.

I hereby freely, voluntarily, and without duress execute this Release under the following terms:

Release and Waiver: I hereby release and forever discharge and hold harmless Purrfect Pets and its successors and assigns from any and all liability, claims, and demands of whatever kind of nature either in law or in equity, which arise or may hereafter arise from my activities with Purrfect Pets.

I understand that this Release discharges Purrfect Pets from any liability or claim that I may have against Purrfect Pets with respect to any bodily injury, personal injury, illness, death or property damage that may result from my activities with Purrfect Pets, whether caused by the negligence of Purrfect Pets or its officers, directors, volunteers, ore agents or otherwise. I also understand that Purrfect Pets does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness. I authorize Purrfect Pets or its volunteers, officers or agents to seek emergency treatment in case of accident, injury or illness.

Medical Treatment: I hereby release and forever discharge Purrfect Pets from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with my activities with Purrfect Pets.

Assumption of the Risk: I understand that the activities included that may be hazardous to me. I hereby expressly and specifically assume the risk of injury or harm in the activities and release Purrfect Pets from all liability for injury, illness, death or property damage resulting from the activities.

Photographic Release: I hereby grant and convey unto Purrfect Pets all right, title, and interest in any and all photographic images and video or audio recordings made by Purrfect Pets during my activities with Purrfect Pets, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

Other: I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Kansas, and that this Release shall be governed by and interpreted in accordance with the laws of the State of Kansas. I agree that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
