

Touchet Gun Club 1947-2006

The Touchet Gun Club had owned and maintained 3.5 acres of land with a club house and shooting range on the Touchet North Road since 1947. In April 2006, members voted to sell the property and donate the proceeds of \$26,000 to the Touchet Educational Foundation. This gift is thankfully accepted on behalf of the Touchet Educational Foundation Board of Directors, volunteers and senior classes—past and present.

January 17, 1947

The original 17 members of the Touchet Gun Club met in the local pool hall. The officers were nominated and voted upon.

Life membership was set at \$10 a piece and the gun club got off to a start with \$170 in the bank. The first trap machine was purchased for \$80. It was decided that they should have at least 1000 shells to get started that was to cost around \$35. They took an inventory of the various shotgun gauges and preparations were made to purchase targets also.

That first evening it was suggested that a clubhouse would be a good idea instead of the pool hall. By-laws were passed, a fence was placed around the trap house, warning signs were erected, committees were formed and the first prizes to be set were hams, bananas and chickens. It was decided that a 22 rifle range would be -too dangerous and that the use of full-auto should be banned. A dance was held at the Grange to help fund the incorporation of the club. A Coca-Cola icebox was exchanged for a new membership.

TRACKING THE INDIANS

MELISSA CUMMINS

I graduated from Touchet High School in 1973. I attended Washington State University, earning a B.A. in Music and Masters of Adult and Continuing Education. I began my USDA career as an extension educator with the University of Minnesota in 1979. completed a M.S. in Agricultural Economics from Penn State University in 1986, and was hired by the USDA Farmers Home Administration in 1987. Prior to becoming a Specialist in the FmHA State Office in 1990, I worked as a field loan officer in Ellensburg and Okanogan. I am currently serving as the Farm Loan Chief of the USDA Farm Service Agency for the State of Washington. This is a unique position in USDA, occupied by only 47 individuals. As the Farm Loan Chief, I am responsible for the implementation and



management of the credit program of FSA throughout Washington State. This involves monitoring a direct and guaranteed lending program totaling more than 220 million dollars. As the FLC, I also am a member of the senior management team of Washington State FSA. Prior to being appointed as the FLC, I served as a state specialist. I became a specialist in 1990, first focusing on management of inventory farm property, and in 1994 as a general loan specialist responsible for litigation, inventory property, disaster programs, environmental compliance, and providing direction to field loan officers in the areas of direct loan making and servicing. As a credit official in FSA, I have also been active in the National Association of Credit Specialists, a professional association representing credit managers with senior management in Washington D.C. I served in the offices of regional representation, Secretary, Vice President and in 2005.2006 as National President. I am currently completing my last term on the Board of Directors as Past President. This opportunity has allowed me to meet with the FSA Administrator and Deputy Administrators on a routine basis, representing the views and concerns of credit management staff as national policy impacting the implementation of the credit programs are formulated. I am also a member of the Federal Manager's Association. Aside from work, I enjoy traveling, and recently accompanied my Mom on a barge cruise in France. In 2005 I enjoyed a trip to Iceland, and traveled to Scotland and Sweden in 2003. I also have traveled extensively around the country. 

- have set a goal of \$25,000 for scholarships to Touchet seniors in the graduating class of 2007 for their pursuit of higher education goals



The last Annual Shoot

September 2001

Wally Fisher, Gordon Wells, James Appling and Gail Martin resigned from the Touchet Gun Club. Terry Schaeffer took over the books and managed the corporation and annual reports until 2006.

June 2005

The gun club had \$950 in accounts and was facing a \$2200 roof repair. The membership decided to sell the property.

January 2006

Property sold to Carolyn Seachris and funds transferred to the Touchet Educational Foundation in February 2006.

February 20, 2006

By-Laws Adopted (Corporation annual report after sale of property)

May 5, 1947

By-Laws Adopted (First 50 year incorporation)

The objects of this corporation are for the social, educational, benevolent, entertainment and recreational benefit of its members; the education of its members in the use of small firearms; fostering of good fellowship, good sportsmanship, benevolent enterprises and the social welfare of its members; the promoting of all lawful types of competitive events involving skill in the use of small firearms, and in particular trap and skeet shooting; to further the interest of its members in the propagation of fish and game and acquiring and maintaining a library pertaining to guns, wildlife, marksmanship and other matters of interest to its members.

President: Alvin Adams, Vice-President: J.A. Anderson, Secretary-Treasurer: Will Hickman, Jr., Field Captain: Frank Broyles, Trustees: Everett Brock & Oran Gluck.

May 26, 1948

Enough money was raised in the first year of shoots to purchase the property. Harlan Seachris sold the property, 3.5 acres, to the Touchet Gun Club for \$250.

The structure was built, painted on the outside, varnished and shellacked on the inside. Another dance was held to help pay off the cost over-run of the construction. The extra 2x4s were also sold off to raise money for the new digs. A fifty-cent fine was also levied for anyone caught spitting on the floor. The first shoots organized were Telegraphic Shoots with blue rock targets.

1950s

In 1951 there were 65 members and in1954 there were 67 members.

October 1988

The property was leased to Carolyn Seachris.

1993

A shoot was held in March, September and December.

April 28, 1994

By-Laws Adopted (First perpetual incorporation)

The object of this organization shall be the encouragement of organized Shotgun Shooting among citizens of the United States resident in out community, with a view towards a better knowledge on part of such citizens of safe handling and proper care of firearms, as well as improved marksmanship. It shall be our further object and purpose to forward the development of those characteristics of honesty, good fellowship, self-discipline, team play and self-reliance which are the essentials of good sportsmanship and the foundation of true patriotism.

The annual meeting of the club shall be held on the third Thursday of January each year.

1994

An Annie Oakley shoot was held in April which had a turnout of 50 shooters. Coffee and donuts were served early in preparation for the day's events. Marve Underwood won a Ruger 10/22-carbine rifle. Drumhellers sponsored the event and the clam chowder was excellent.


