We are also required to enforce our architectural standards to maintain the quality of the exterior of homes and landscaping of yards. The objective is to maintain the resale values of all homes in our subdivision so buvers will be attracted to our neighborhood. USE DOOR SIGN TO PROHIBIT SOLICITORS

The HOA does not have the authority to prevent solicitors from coming to our neighborhood but the Town of Flower Mound has a very restrictive ordinance that helps prevent them from bothering us. The easiest solution is to post a door sign.

Flower Mound Code of Ordinances Article IV Solicitation Activities sets forth the requirements for vendors soliciting business on residential premises. Sec. 18-263, **Exhibiting Card Prohibiting Solicitors** provides that any person desiring that no merchant or other person engage in a home solicitation at his residence shall exhibit in a conspicuous place upon or near the main entrance to the residence a weatherproof card not less than three inches by four inches in size, containing the words "**NO SOLICITORS.**" The letters shall not be less than two-thirds of an inch in height. This provision is legally enforceable.

Several Shadow Ridge South homeowners have placed **NO SOLICITORS; NO HANDBILLS** signs on their front doors. Not only do they not have solicitors knocking, but also the placing of handbills is almost nonexistent.

SOLUTIONS FOR BARE GROUND UNDER SHADE TREES

The builders of our homes at Shadow Ridge South planted Bermuda grass for our lawns, as this is a fastgrowing turf that is great for the hot and dry North Texas climate. Unfortunately, it does not grow well in shaded areas, and as our trees have matured the Bermuda grass has died off and left large areas of bare dirt under them. The HOA's landscape maintenance company recommends homeowners first trim their trees to raise the canopy to let more sunlight through to the turf. One alternative for bare spots is St. Augustine sod (look for drought-tolerant varieties like Floratam/Tamstar) overseeded with Fescue. Another is Palisades Zoysia, a shade-tolerant alternative to St. Augustine that uses less water. Bermuda is still the best grass for sunny lawns, as it requires half the water of St. Augustine and isn't as vulnerable to disease or insect attacks.
