

AOK! Fitness Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.aokfitness.com and AOK! Fitness, LTD and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to AOK! Fitness, LTD include www.aokfitness.com and AOK! Fitness. The AOK! Fitness website is a ecommerce site. By using the AOK! Fitness website, you consent to the data practices described in this statement.

Privacy Compliance Certification

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, AOK! Fitness may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase AOK! Fitness's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Sharing Information with Third Parties

Tracking User Behavior
