Charles Leipprandt at St. Paul's Evangelical United Brethren Church, Elkton, on April 13, 1951. Chuck preceded her in death on April 18, 2015. In addition to being a homemaker throughout her lifetime, Doris worked for three years at Thumb National Bank in Pigeon. She was an active member of Hayes United Methodist Church, where she sang in the choir, was a delegate to the Annual Church Conference, and was active with the United Methodist Women.
