Minutes of June 19, 2023

The Huntington Township Trustees met in a regular scheduled meeting at 7:00 PM called to order with the pledge of Allegiance. Attendees: Robert Holmes, Jed Lamb, Walter Rollin, Sheila Lanning, Matt Combs, Frances Rollin, Carl Strekely and Alaina Combs. *Motion* by Holmes with a second by Rollin to approve the minutes of June 5, 2023 as written. Roll call: three yeas. Checks 10340 – 10351 and payments totaling \$13,251.89 were approved for payment. Lamb had no knowledge of the work done by his brother (Lamb Electric) and did not sign the payment. *Motion* by Holmes with a second by Rollin to approve *Resolution* 2023-41 amending appropriations. Roll call: three yeas. Lanning: No receipt yet of the ARPA Storm water grant for Stewart Road Culvert replacement. Need to advance money from General Fund to pay the vendor for the culvert. The advance is part of the appropriations amendment. Provided the Trustees with the proposed 2024 budget worksheets and narrative. Need to set a public hearing for 2024 budget which is due to the Tax Commission 7/20/2023.

COMMITTEE REPORTS:

WATER BOARD- Lamb: Water was shut off 6/9/2023 for a few hours due to a main line break. The redundant system worked during this break.

LORCO- Lamb: plugging along.

AMBULANCE- Holmes: Total miles for May =4,398, year to date = 19,238. Maintenance cost for May \$4,648.56, year to date = \$17,096.94. Huntington runs = 13, year to date =41. District runs for May = 130, year to date = 601. Helipad ready for sealcoat and lighting. Bought new radio's, if the Commissioners do something with the money, we won't see a cent of it.

FIRE- Rollin- bought new radio's, up to 40% of the original cost.

OPWC & SWAC- Combs: Stewart Road culvert replacement done, road opened in two days. Lanning: are we applying for OPWC money for a project. Combs: Stewart Road.

CEMETERY- Rollin: Still need to put a process for Military markers on Website. Meeting with TC Energy and Lorain County Prosecutor and Lorain County Engineer on 6/8/2023. Engineer (Klaiber) is making up drawing of proposed extension package. TC Energy looking into lease and requirements. Lanning: Lease was redone in 2013 by Dave Clark after a meeting with Trustees. Beverly Keathley asked about lot #217 West, Eastman Funeral Home called about the process for military markers. They are ordering one for Mr. Richard Chester. Sheila updated the veterans memorial call list with Richard Chester and Don Rollin. Talked to Doug and Peggy Hasting to update their list used for placement of wreaths and flags.

RECYCLING- Lamb: any money from Country view Recycling. Lanning: yes, will have the amount for the next meeting.

ROADS- Combs: still need to patch in preparation for chip/seal. Lamb: email received from Ms. Murray about a hidden drive sign on Griggs Road. This is a county road so it is in their hands.

EQUIPMENT- Combs:

ZONING- Klebow sent updated status report.

EMPLOYEES- Combs: Attending Road Safety training August 2nd & 3rd with Robert Bort. *Motion* by Rollin with a second by Holmes to authorize the attendance of the training 8/2 & 8/3 and to approve per diem of \$60.00 per day/ per person plus mileage and hotel expenses. Roll call: 3 yeas. Lanning: Township is tax exempt, use the proper forms. Lamb: there is a bed/lodging tax also that you will need a tax-exempt form.

PREVIOUS BUSINESS

Holmes: Nothing further on ARPA money for safety building. Lamb: Fences are repaired, received a question from Kelsey asked about putting in a gate that joins the Township Fence. Combs: no quotes yet for a new man door on the Garage. Lanning: letters sent to chip/seal bidders thanking them. The contracts for the bid winner (Geauga Highway) need executed. No revised quote received for changes to the bid of Township
