

12/31/2018

SSgt. Warner, Deputy Barton, Deputy Norman, Deputy Copley and Deputy Galloway responded to a residence on State Route 255 in reference to a domestic with shots fired. Shortly after arriving on scene, James Bloom was taken into custody. During the course of their investigation, it was determined that James and his son got into a physical altercation. At some point, James grabbed a .12 gauge shot gun and discharged it. James was booked in to the Monroe County Jail for Aggravative Assault, Domestic Violence, Weapons under Disability and Resisting arrest.

Deputy Galloway was dispatched to a residence in Duffy due to a homeowner wanting two people removed. A relative picked up the subjects shortly after Deputy Galloway arrived on scene.

Deputy Copley was dispatched to Jerusalem in reference to an accident involving a car and Amish Buggy. No injuries were reported and before his arrival, the Amish Buggy left the scene. The parties did not wish to make a report.

Deputy Galloway was dispatched to Griffith Road in reference to property damage due to semi traffic.

Deputy Copley was dispatched to State Route 565 in reference to a one vehicle accident. No injuries were reported. Information was taken for a report.

Deputy Weekly, Deputy Ridley and K-9 Ax responded to a domestic disturbance on Moore Ridge Road in Malaga Township. Upon arriving at the location and speaking with the subjects, it was determined there was no actual domestic, just a verbal disagreement between the parties. The parties were separated for the night.

Deputy Copley and Sgt. Yonley responded to a one vehicle accident on Keylor Hill Road. The driver of the vehicle was not injured. However, the driver was arrested for OVI and transported to the Monroe County Jail.

Deputy Weekley came into contact with a vehicle stuck in a ditch on State Route 145 in Malaga Township. Stephens Towing came to the scene and pulled the vehicle out and no damage was done.

Sgt. Yonley, Deputy Weekley, Deputy Ridley and K-9 Ax responded to a possible suicidal male in Clarington. Upon speaking with the subject, no threats were made and no evidence was shown to take the subject into custody.

1/1/2019

Deputy Copley initiated a traffic stop on State Route 800 in Malaga Township. During the course of the investigation, it was determined the subject was operating a vehicle while intoxicated. The subject was transported to the Monroe County Jail.

Deputy Galloway investigated a one vehicle accident on State Route 800 in Center Township. The driver of the vehicle fled the scene and Stephens Towing recovered the vehicle. Investigation pending.

Deputy Galloway was dispatched to State Route 78 near Salem Run Road in Salem Township in reference to a tree down. Deputy Galloway removed the tree from the roadway.

Deputy Weekley responded to Beallsville in reference to a possible prowler call. Upon the investigation, it was determined to be the furnace making the noise that alarmed the subjects inside the house.

Sgt. Yonley spoke to a female subject in reference to filing charges on another for threats. After questioning the subject, it was determined the incident took place in Moundsville WV.

Deputy Ridley spoke to a female subject in reference to her mother sending her text messages and causing an alarm to her. The other party was contacted and advised not to have any contact with the reporting party or possible charges could be sought.

1/2/2019

Sgt. Smith and Deputy Schumeran responded to a residence in Franklin Township for an elderly male who passed away. Investigation showed no signs of foul play and his death was ruled natural.

Deputy Norman responded to Skin Creek Road in reference to a male violating a protection order and photographing his Amish neighbors. Several attempts were made at the Woodland Court address, but no contact was made with the son.

Sgt. Warner spoke to a female on the phone advising that she felt her elderly mother is being taken advantage of by her boyfriend. She advised that her mother has dementia and she thinks her boyfriend is going to take her out of state. The caller was advised that we would check on her mother's well being and speak to the boyfriend in reference to his intentions.

Sgt. Warner responded to an abandoned 9-1-1 call on State Route 255. The male subject living upstairs advised that he didn't call and there was no emergency. He informed me that a female lived downstairs in the residence, but she was not home. No contact was made with anyone in the downstairs residence.

1/3/2019

Deputy Schuerman investigated a one vehicle crash on State Route 7 in Lee Township. No injuries occurred, and a crash report was taken.

Deputy Norman responded to a call of a reckless driver that ran in the ditch on State Route 7 near Clarington. After investigating the scene, the driver was transported to the hospital by Sardis EMS. The vehicle was removed by A&S Towing. The incident is still under investigation.

Sgt. Warner responded to a residence on Bondi Ridge Road in reference to a check for well being of an elderly female. It was discovered that the daughter was there with her elderly mother and she was discovered in good health.

Deputy Barton handled a walk-in in complaint in reference to vandalism that had occurred at well site on Dye Ridge Road. Information was taken for a report to be completed and the incident will be investigated further.

Deputy Barton responded to New Matamoras in reference to an ATV that had been discovered possibly matching the description of one reported stolen from Monroe County. After viewing the ATV, it was discovered no to be the same one.

Sgt. Warner, Deputy Norman and Deputy Barton assisted the Monroe County Detectives investigating a drug trafficking in Woodsfield. Michelle Walls and Tony Walls were arrested and transported to the Monroe County Jail.

1/4/2019

The driver Challis Howell was arrested for drug charges and driving under suspension. The passenger Gina Loy was arrested for drug charges, tampering with evidence, falsification and an active warrant out of Monroe County Court. Both subjects were taken to the Monroe County Jail.

1/5/2019
