Treasurer's Monthly Report

The balances for all accounts as of September 30, 2018, (reported on October 8, 2018) are as follows: Checking - \$1,705.93; Investment Savings - \$149,864.39; and Town CD's - \$125,000.00. Total town funds now are \$276,570.32.

Larry Katerzynske stated that when he drove by Spooks on Spurr on Friday and Saturday nights he saw no parking on the roads.

Specific matters for discussion and possible action:

- **A.** Andy Gayhart from Harters- discussion of trash pickup renewal- Nick Achtenmeier attended in place of Gayhart. He stated that he feels Harters has done a good job and would like to remain our trash hauler. He presented new pricing which drops the monthly pickup per household to \$10 from the current \$11.25. Korth asked about the trucks being closed to limit trash flying out. Clerk stated that when he calls Harters with an issue, they respond quickly.
- **B.** Tax Collector bond- Horton Group- <u>Gitter made a motion, seconded by Korth, to renew our tax</u> <u>collector bond with Horton Group for the 2018-19 tax year in the amount of \$250,000 for a premium of \$100. MOTION CARRIED.</u>
- **C. Quarterly Clerk / Treasurer reconciliation-** Katerzynske presented the 3rd quarter 2018 reconciliation. Board accepted it without comment.

Report of officers: Clerk: County Zoning planning meeting is at Town Hall on 10/11/18 at 6:30 PM. Cemetery: Coroneos stated we've saved hundreds of dollars in mowing due to new mower. Also seems to be a lot more burials this year. He noted the City of New London had to dig our last two graves. Constable: one lost dog call. Building Inspectors: none. Raft: none. Planning Commission: none.
