MEMBER CONTRACT 2018–2019

I agree to the following:

To pay the full year's tuition for the 2018-2019 school year, as determined by the Granville Parent Cooperative Preschool's Board, at the rate I have selected below. In accordance with the by-laws, I agree that an amount equal to one quarter of the year's tuition will be retained as a **NON REFUNDABLE DEPOSIT** should I withdraw my child from the preschool any time before the first day of class.

One Time Payment

Pay full amount of tuition by June 15, 2018. (The deposit is included in the figures below.)

\$525 for 2's
\$1130 for 3's
\$1585 for Multi-Age
\$2165 for 4/5's

Monthly Payments

Pay ¼ of tuition by June 15, 2018. Monthly payments divided over 7 months (Sept-March).

\$53.50 per monthly payment for 2's	(\$150 due by June 15 th)
\$121 per monthly payment for 3's	(\$283 due by June 15 th)
\$170 per monthly payment for Multi-Age	(\$395 due by June 15 th)
\$232 per monthly payment for 4/5's	(\$541 due by June 15 th)

Four Installments

Pay tuition in four installments according to the following schedule:

June 15, 2018
October 15, 2018
January 15, 2019
March 15, 2019

\$125.00 per payment for the 2's
\$283 per payment for the 3's
\$395 per payment for the Multi-Age
\$541 per payment for the 4/5's

I agree:

1. To pay these installments on time or be assessed a \$25.00 late fee for payments later than 14 days. Payments 14 or more days late may result in further action (Article IV, Sec. 1). I understand there is a \$30 returned check fee.
2. To take/keep my child home if there are any signs of a new cold or any communicable disease in accordance with the bylaws (Article VIII, Sections 2, 3, 4, 5).
3. To take my turn, as requested, in assisting the teacher at the preschool. This will occur approximately 12 to 15 times, or more as needed, during the year for the 3's, Multi-Age, and 4's/5's classes and on a rotating basis for the 2's Toddler & Me program.
4. To exchange days with another enrolled parent in case I am not able to act as a helping parent on my assigned day as stated in the bylaws (Article IV, Section 7).
5. To pick my child up promptly from school or, as stated in the bylaws (Article IV, Sec.14), be accountable for the imposed penalties.
6. To complete parent projects equal to two points (or one for members of the 2's class) or serve on the board, as stated in the bylaws (Article IV, Sections 10, 11).
