1) Welcome/ Introduction
a) 18 people present
2) Review of Minutes- Shawna Stevens
a) Soji Howe moved to approve September 19, 2017 minutes with recommended changes; Tina Zicari seconded the motion; motion passed.
3) Vice President's Report- Cindy Pickett
a) Fundraising: Usually have a fall event that is mainly a community building event to connect with Montessori families. This is normally at Round Table Pizza- do we want to try something different? 5) Teacher's Reports

Lakshmi Aradhya (5/6): $5^{\text {th }}$ graders attended Grow and Give field trip at Farm 2.6. Kids design the menu and then plant the vegetables. They then harvest veggies and make a meal for the seniors. $5^{\text {th }}$ grade literature group reading One and Only Ivan; $6^{\text {th }}$ graders are reading Island of the Blue Dolphins and Where the Mountain Meets the Moondioramas will be part of their presentation. Each grade works on grade-specific math while other grade is at PE.
Kelly Vellanoweth (K/1): Student field trip to Impossible Acres led into the life cycle of pumpkins. Kinders are using the moveable alphabet and learning the snake game; $1^{\text {st }}$ graders are working on static addition with golden beads and learning compound words. PE activities include yoga and zumba. Ms. Aradhya's class are big buddies; fun to hang out with them.
Remy Glovin (2/3): Class went to see the play Aladdin and traveled there on bikes-great fun. Students will be studying Asia in the winter will incorporate more ideas from Aladdin.
