PLEASE NOTE THAT THIS LIMITED WARRANTY APPLIES ONLY WHEN THE PRODUCT PURCHASED IS USED FOR THE FOLLOWING PURPOSES AND ON THE FOLLOWING SURFACES:

1. Residential Purposes (Homeowners or contractors using the product for single or multi-unit dwellings that are used exclusively for residential use) on:

- Horizontal surfaces
- Vertical surfaces (walls and masonry)

2. Commercial or Other Purposes ("Other Purposes" include mixed-use, institutional or non-residential purpose) on only:

- Vertical surfaces (walls and masonry)

PLEASE NOTE THAT THIS LIMITED WARRANTY COVERS THE FOLLOWING PRODUCT DEFECTS BASED ON PROPER MAINTENANCE:

- Fading
- Cracking
- Permeability
- Weed growth
- Wash out

PROPER MAINTENANCE - The resin in the product can cause a temporary stain on the surface of certain manufactured stones and pavers which may persist for a period of up to 6 months after installation. Because the product is air and water permeable, dust, soil, or other organic debris can lock into the joints over time and this may cause an apparent color change. Proper maintenance includes rinsing the joints with a soft stream of water and lightly brushing with a medium to stiff brush if necessary. DO NOT use a power washer directly into the joints as this could cause the product to crack or loosen.

However, for a period of 1 year from date of purchase, TEXAS QUICKSAND LLC agrees that, if the product is proven to be defective with respect to the specific purposes, surfaces and maintenance procedures stated above, and on the condition that it was applied pursuant to the method of application described in the applicable instructions, then TEXAS QUICKSAND LLC agrees to refund the purchase price. Proof of purchase is required for any claim. The parties agree that the refund of the purchase price as stated is the only obligation of the TEXAS QUICKSAND LLC. In all events, TEXAS QUICKSAND LLC shall not be liable for any other damages or costs (including, without limitation, removal or reinstallation of pavers, bricks, stones, sand or mortar) whatsoever, direct or consequential.
