# Potential Improvements to our Community

The Moorings HOA board is considering projects to improve the look and livability of our neighborhood. Which project(s) we choose to fund will be determined by the amount of money raised during our current dues drive, and by your vote! Read the preliminary project descriptions below, and then cast your vote.

#### Project #1: Restoring the Jolly Roger Hedge

Our fearless HOA president removed most of the dead podocarpus and trimmed others. This project would replace approximately 55 of the shrubs.

#### Project #2: Doggy Bag Dispensers and Receptacles

The goal is to encourage pet owners to pick up after their animals. The dispensers might be located along the Jolly Roger/South Patrick Drive paths. Some volunteer maintenance would be required to keep the dispensers full of bags, and to empty the receptacle.

#### Project #3: Organize an Evening Dinner Event

Some residents have expressed an interest in an alternative to the beach BBQs. This event might be held at a local restaurant or other venue. The HOA would subsidize part of the cost.

#### Project #4: Restore Front Entrance

The goal is to emphasize the giant anchors and coquina rock at the front entrance by removing some landscaping.

#### Project #5: Add Two Paths from the Moorings to the Bike Path

Create two paths through the hedge at Port Royal and St. Lucia to provide easier access to the bike path along South Patrick Drive.

#### Project #6: Update Front Entrance Sign

The goal is to create a more modern/stylish sign at the front entrance with a stone and tile base.

#### Project #7: Refresh the South Entrance

The goal is to improve the look of the south entrance at Aruba Ct. If the main entrance sign is updated, the current sign could be relocated here. The pilings could use a fresh coat of paint, and the light fixtures could be updated.

#### Project #8: Install Oxygenating "Bubblers" in the Canals


The goal is to improve the health of our canals by dropping aeration devices into the water.


# A Note from the Moorings Homeowners Association President

# **Results of Improvement Poll**


Last month we solicited your opinions on which potential project(s) you'd like to see the Moorings Homeowners Association tackle. We have the preliminary results (although your opinion is still welcome). As shown in the chart below, most residents wanted to see something done to improve the water quality of our canals, restore the hedge along Jolly Roger, and improve the two entrances to the Moorings. The HOA board is in the process of calculating our recurring expenses, determining the amount left, and investigating cost options for various improvement projects. We have started on the Jolly Roger hedge by having the irrigation system repaired (no sense in putting in new plantings if they don't get watered regularly). The Moorings Roads & Grounds guy, José Bermudez, tells us that Brevard County is paying for this part of the project.

#### Thirsty Lawn?


It's been a very dry February and March this year, and some of our lawns show it. A reminder that we are once again allowed to use our lawn sprinklers **twice a week**, now that daylight saving time is in effect. This might also be a good time to check the operation of your irrigation system.

#### Flying a Service Flag

At the request of Marie and John Lee (401 St. Georges Ct.), the Moorings will be flying a flag for their son on the main entrance flagpole. Bobby Lee is serving in the U.S. Air Force in Iraq. If you would like a flag flown in the honor of an immediate family member who is deployed to a combat zone overseas, please contact Frank Tuozzo (321-622-5151), our Moorings flag custodian. Please provide a squadron, unit, or service flag. It will be flown for a minimum of one month.

# **Proposed Projects**

We tabulated your votes for the improvements you'd like to see made in our community. The primary concern was the water quality of our canals. We have talked with the Marine Resources Council, and there are no easy fixes. We are still due to get the canals dredged of muck. That project is

funded by the government, but is waiting on environmental and wildlife approval. Our waterways guy, Cole Panning, is investigating a low cost aeration system. And we all can help the water quality by making sure our lawn services don't blow cut grass into the canal, picking up after our pets, and by not washing our cars in our driveways. The county may perform a "smoke test" of the sewage system in our area to identify leaks in the pipes.

The other project which received major support was restoring the hedge along Jolly Roger Drive. We are reluctant to buy new plants to replace the ones that died last year until the irrigation system is working properly. Our Roads & Ground guy, José Bermudez, reports the county has hired a contractor, who identified problem areas (that's why there are flags at the sprinklers along Jolly Roger). Hopefully, they will repair the irrigation system soon.

The third most popular project, based on your votes, was sprucing up the front entrance. There are many interpretations as to what that means (removing existing plants, pressure washing the coquina rock, improving the lighting, etc.) We'd be interested in any ideas you might have. Please email us with your thoughts, or even proposed designs!

Cole and his team has been doing quite a bit of work towards this and should have a decision soon. #### Update on the Lagoon

The Moorings waterways guy, Cole Panning, attended a recent county commission meeting on the status of the Indian River Lagoon. Here's his summary of the four hour meeting:

- The removal of muck from our canals is still waiting on permits from the Federal Marine Fisheries Department.
- The county commissioners rejected a proposal to redirect tourist tax funds from sports projects to improving sewer systems to help the lagoon.
- The county is considering a moratorium on permitting new conventional septic tanks. There are roughly 5,000 septic systems in the area, some of which leak into the lagoon.

Our area is in line for "smoke testing" of our sewer systems. They will blow "smoke" into a nearby manhole and you may see it exiting from the vent stack on your roof (a good sign) or from holes in the ground (a bad sign). The test is designed to locate leaks in the sewer pipes. The county will notify us via door hangers the week prior to testing.

#### SPRA Report

Ayn Samuelson of the South Patrick Residents Association tells us that the county still plans on moving the sewage "lift station" at the corner of St Georges and Jolly Roger. Our waste water moves in high pressure pipes to the treatment plant, and the "lift station" is a pump that keeps it moving. The lift station, currently at the northwest corner of the intersection, may be moved to the southwest corner. However, the County is still negotiating with the State to install a new lift station in the green space along South Patrick Drive. Final plans are on hold until the South Patrick location is approved or rejected. Ayn also reports that the temporary electrical connection on the northeast corner of St Georges and Jolly Roger is being worked on. The County is installing a new electrical conduit, however FPL will do the actual electrical connection. Timeframe for that is unknown. The next meeting of the South Patrick Residents Association will be held on Monday, June 11th at 7:30PM in the David Schechter Center.

#### Roads & Grounds Report

José Bermudez, our Roads & Grounds guy, reports that the County has mulched the beds along Jolly Roger Drive, and around the front entrance. But the County has yet to fix the irrigation system that runs along Jolly Roger. It turned out to be more complicated than initially thought, and the County is soliciting bids before issuing a purchase order. We are reluctant to plant new podocarpus before the irrigation system is repaired.

#### **Money Matters**

Our Moorings Treasurer, Brenda Merchberger, has tallied up the dues collected for 2018. Thanks to you, we collected the second highest total in six years (but it's not too late if you haven't contributed yet). The street race ended with Bridgetown Court in first place, St Georges Court in second place, and St Lucia Court with the third highest dues collected. Our account now holds \$14,819.

Many thanks to the Moorings Social Director, Jeannine Hall, for organizing the Spring Fling BBQ, and for opening her porch for the pickup of meals. Unfortunately an inclement weather forecast resulted in a cancellation of the event.

# Oyster Bed Installation Signup

In our recent survey of Moorings improvement projects, the majority of respondents gave the quality of the water in our canals the top priority. We found a great opportunity for us to participate in a free project that uses oyster beds to clean the water. An adult oyster is capable of filtering up to 50 gallons of water per day. BUT we have to ACT NOW as a group to be considered for installation this summer. Clyde is collecting signup info and Cole (Waterways board member 321-773-5763, <u>cpanning@aol.com</u>) is taking over the program to answer questions and help with logistics. <u>Please send an email to Clyde Bridge</u> or text/call 321-258-7401 before June 7th with the below information if you want to be considered for the Brevard County/Zoo project that will install oyster beds on your property at no cost to you:

- Property owners legal name (and current resident, if not owner).
- Contact phone number.
- Contact email.
- Property's street address.

Answers to your questions:

- You do NOT need to perform any maintenance on the oysters.
- You do NOT need a dock or pilings.
- The oysters will be placed in bags near your seawall.
- The oysters are not detrimental to your seawall. The program director actually cited cases where seawalls were better supported with the oysters than those without (based on damage from last two hurricanes).
- The oysters will not grow to the top of the water and continue to take over the canal to eventually restrict and cut-off waterway navigation. Oysters generally will only grow on a hard substrate / on top of the installed bags and not go into the sandy bottom of the canal.
- This is not the "Oyster Gardening" program so many are familiar with. The "Oyster Gardening" program had the home owner growing oysters in cages, required home owner maintenance, and eventually returns the oysters to the zoo for reef creation elsewhere in the county.

• The Brevard Zoo and Brevard County are joining forces (and funding) to install permanent oyster beds on resident properties throughout the county.

• If we act fast, we can participate in this phase of the program, with oyster bed installations sometime this summer. The next opportunity to signup is Jan 2019 with the next install in summer 2019.

County / program approvals are based on a three factors (> 1' depth water, no sea grass, & amount of waterfront property). We will submit as a single HOA to be considered a larger single project but individual parcel size will still matter ( i.e. the more neighbors we get to participate, the better our chances are to be approved for this install). The total number of houses that sign up will be considered but the more side-by-side neighbors that sign up the better (continuous oyster reef is hardier and more likely to survive).

# Update on Muck Removal

The South Patrick Residents Association hosted a presentation about muck removal by the Brevard Natural Resources Management Department recently. Here are some highlights:

- Schedule: Permits have been issued, bids for the project will be received this fall, with muck removal beginning late this year/ early next year. It is estimated to be a two to three year project.
- Nearly half a million cubic yards of muck will be removed from the Grand Canal and finger canals (all canals in the Moorings will be involved).
- The dredged material will be "de-watered" at a site south of the Pineda Causeway.
- Homeowners will receive waiver letters to sign, to allow the contractors to dredge up to five feet from your pilings and seawalls. (Otherwise there would be a ten foot offset from any waterfront structures.)

The President of the South Patrick Residents Association, Ayn Samuelson, is concerned that once our North Grand Canal Project is completed, in 2 to 3 years, that the same 6.83 acre parcel at the north end of the Grand Canal might also be used for muck deposition and dewatering from other portions of the Grand Canal system located within the cities of Satellite Beach and Indian Harbour Beach, for which separate funding, dewatering locations, and transport should be planned. The County commission will hold a public meeting to approve the annual temporary use agreement (TUA) for our de-watering site, and we should demand assurances the site will be restored, and not used for other projects, after the northern de-mucking is completed. Otherwise, our residents could be subject to an additional 4 to 6 years of muck dredging impacts.

# **Correction to De-mucking Article**

Thanks to Randy Scully, we learned that not all the canals in the Moorings will be dredged. We contacted the department, and they confirmed that canal was removed from the project during the permitting process due to manatee concerns.

# Gators in our Canals

It's best to keep small pets away from the water when an alligator has been sighted in your canal. The Florida Fish and Wildlife Conservation Commission does offer a free program to remove "nuisance" alligators. Generally, an alligator may be deemed a "nuisance" if it is AT LEAST four feet in length and you believe it poses a threat to people, pets or property. The FWC says "alligators less than 4 feet in length are not large enough to be dangerous unless handled. They eat fish, frogs and other small animals. Typically, they are not large enough to be a threat even to small pets. The mere presence of a small alligator is not cause for concern. Occasionally, alligators less than 4 feet in length are legitimate problems and must be addressed." Call the Nuisance Alligator Hotline at 866-FWC-GATOR (\*\* 866-392-4286 (tel:866-392-4286)). If your complaint meets their criteria, the FWC will hire an independent trapper to remove the gator.

# Please Remember the Restrictions

County Safety Vehicle Request (HOA Covenants & Restrictions #5): Try not to park in the street if you have room in your garage or driveway. If you do not have room and must park in the street, please park your vehicle in the grass as much as possible to allow maximum road clearance for emergency vehicles (as well as our residents).

Garbage Can Request (HOA Covenants & Restrictions #13): Please make your best effort to move your trash and recycle bins and hide them from the street view during non-collection days.

Yard Signs (HOA Covenants & Restrictions #6) Only "Home for Sale" or "Home for Rent" signs are allowed in our yards. We point this out since we are entering election season.

# Update on Oysters

Many of you signed up for having oysters placed along your seawall to help improve the quality of the water in our canals. The Moorings Waterways volunteer, Cole Panning, has an update on the project.

The manager at Brevard Zoo responsible for the oyster project told Cole that there are three main hurdles to cross in the process:

- 1. Obtaining federal permits through the Army Corps of Engineers,
- 2. Obtaining state permits through the Florida Dept of Environmental Protection and/or local water management district, and
- 3. Brevard County approval to fund the project.

The zoo met with the Army Corps of Engineers to discuss the process of permitting such a long project with so many separate property owners and they made a lot of headway. There is now a plan and an informal agreement in place regarding the permitting process for our community's canal oyster reefs.

The zoo is still discussing this project with the State but is hopeful that it will get a roadmap in place soon and will have staff out to survey the properties this month. Then the project(s) will get submitted to the County for funding in November.

In related news, Cole reminds residents of the north side of St Georges Ct and the south side of Port Royal Blvd that your canal will not be dredged to remove muck. If you have concerns you may contact IRLProject@brevardfl.gov.

#### Warning to Solicitors

We have installed "No Soliciting" signs at both entrances to the Moorings. They are meant to deter aggressive or annoying door-to-door solicitors. But the HOA Board will consider approving neighborhood non-profit solicitation requests on a case-by-case basis. Many thanks to Roads & Grounds volunteer José Bermudez and HOA President Clyde Bridge for installing the signs!

# Parking is a Problem

We recognize that it's difficult for some families to fit all their cars in their garage or driveway, particularly when guests are visiting. But parking overnight on our streets is a violation of Moorings Covenants, and a county ordinance prohibits blocking the sidewalk. During the day, consider not parking on the street across from another vehicle; it might block emergency vehicles or garbage trucks. Consider parking on the grass.

# Update on Sewage Lift Station

Brevard County maintains a pump at the northwest corner of St Georges Ct and Jolly Roger to send raw sewage on its way to the treatment plant. They will be replacing this lift station and moving it to either the southwest corner (at the site of the new home under construction) or the northeast corner of the intersection. The exact location and schedule for construction have not been finalized. Ayn Samuelson of the South Patrick Residents Association warns that the northeastern location may pose a pollution risk to the nearby canal. The contractor is obligated to provide us access to our homes during the process, but the construction will be disruptive to our community. The county just completed a similar project at the entrance to Lake Shepard, and you may have noticed the mess it created.
