Salute to the Flag:

Public Participation:

ECS Partnerships – proposed subdivision for Washington Township, Engineer and Solicitor reviewed.

As Discussed:

- Subdivision meets the general criteria of the Washington Township Subdivision and Land development Ordinance for sketch of preliminary plan submission.
- ➤ Final Plan requires proper sewage disposal a planning component from DEP and stormwater management. Section 402 of the Subdivision and Land Development Ordinance.
- ➤ CMSA requires RUS approval for sewer extension, no written approval has been forwarded by RUS to CMSA as of the current date.
- ➤ Modification of previously approved DEP planning, no approval from DEP as of the current date
- Once RUS/DEP approvals have been received, Developer's Agreement with CMSA must be finalized.
- ➤ Developer's Agreement back to RUS for final approval.
- **ECS** Partnerships developing the sewage system for the proposed subdivision.

Street lighting Program- Level Road, Delmanison Drive, Maple Drive, Oak Street and Sugar Street. As Discussed:

- The public participation in paying for the Street lighting program.
- ➤ The Agreement between Penelec and Washington Township on behalf of the township residents.
- ➤ The \$25.00 annual assessment fees to those residents that benefit from the street lights.

Pat Shedlock thanked the Roadmaster for fixing the road at the intersections of Blueberry and Ryan Streets. Temporary fix, a new catch basin will be installed later this summer.

Chad Pysher commented the recent article in the Mainliner has helped with the ATV traffic on Memorial Drive; suggest signing for the ATV traffic, and inquired about a Nuisance Ordinance. Township Supervisors thanked Mr. Pysher for his previously submitted Dog Park information. Supervisor Hartline checked for general liability insurance on the dog park, Ebensburg Insurance representative told the township they are covered under the general liability policy that Washington Township currently holds, with no additional premiums increase.

Non toxic smoke will be used in the training exercise on or near May 12th and May 16th, 2011, as discussed the liability to the township during the training exercises and the indemnification agreement, for a time period of 60 days then the building should be razed for insurance purposes. Chief Crum also invited all to the LCVFD to inspect the new tanker truck purchased by the fire company.
