### GA Ordinance – Review/Adopt

Need to have public hearing on GA Ordinance and to adopt it. Selectmen using MMA model ordinance as a template. There are appendices describing different levels in assistance.

### Warrant Articles Policy – Review/ Adopt

Policy states guidelines on how warrant articles are able to be placed in the town warrant. The number of voters that participate in the gubernatorial election determines the amount of signatures that are required for residents to post an article in the warrant. Need to add planning board section allowing the board to include articles pertaining to land use. Also need to add guidelines for non-profit organizations. Another draft will be reviewed and voted on next meeting.

### Marijuana Moratorium

Residents submitted a petition with all the required signatures for an emergency moratorium and to schedule a public hearing. The moratorium does not apply to medical growing, patients or caregivers. The Town is able to regulate dispensaries. Bill Diamond is involved in this issue. Will work with the Town's attorney and schedule public hearing as soon as possible.

### Memorial for Robert Gray

A memorial service for Robert Gray will be at the Memorial Park by the Library on Sunday May 22<sup>nd</sup> at 2pm. If rain, it will be held at the East Baldwin Church. Robert Gray was a decorated Vietnam Vet and well known resident of Baldwin. Cynthia Rodlin summarized all his various awards and medals.
