NEW YORK

The federal courts in New York were established under the terms of the Judiciary Act of 1789, and were organized as a single district. The Act of 1801 divided the state into the districts of Albany and New York with just one judgeship, but the act was repealed the following year and the state reverted to single-district status. The District of New York nevertheless was the first to receive a second judgeship, this coming in 1812. Two years later the state was reorganized into the Northern and Southern Districts, with the original judgeship assigned to the Northern District (see Judge Duane's succession line), and the position created in 1812 going to the Southern District. The Eastern District was carved out of portions of the Southern District in 1865, and in 1900 the Western District was created from counties in the Northern District.

NY.SD.05 and 06 were created in 1922 as temporary lines but both were converted to permanent in 1935. NY.SD.12 initially was a temporary line in 1938 as well, with the usual stipulation that the next vacancy on the court would not be filled. It appeared that the position would end with the elevation of Judge Patterson (NY.SD.04.03) the Court of Appeals for the Second Circuit in 1939, but the following year Congress repealed the proviso, and the line was able to resume with the commission of Judge Rifkind in 1941. NY.SD.13 also was authorized as temporary, again with the customary restriction that

the first vacancy to occur on the court would not be filled. When Judge Woolsey (NY.SD.09.01) retired in 1943, his line ended and NY.SD.13 effectively became the permanent one.

NY.ED.03 was authorized as a temporary position in 1922 and converted to permanent in 1935. On another matter, Congress stipulated in the Act of February 25, 1919 that if the president (and later the circuit judicial council) finds that a disabled judge is eligible to retire but refuses to leave the bench, the President can appoint an additional judge. Upon the departure of the former judge, the line ends. It was under this provision that NY.ND.02 was authorized as temporary. With the death of Judge Ray in 1925, NY.ND.01 ended and NY.ND.02 became the permanent line. The temporary seat (NY.ND.06) legislated in 1990 was reauthorized seven years later, and made permanent in 2002. NY.WD.04 was authorized as temporary in 1984 and converted to permanent by the 1990 judgeship legislation.

New York is in the Second Circuit and has fifty-two authorized judgeships distributed as follows: five in the Northern District, fifteen in the Eastern, twenty-eight in the Southern, and four in the Western.
