

## Rosebud's Child Care and Learning Parent/Provider Agreement

This Agreement is made between \_\_\_\_\_ the parent(s) of \_\_\_\_\_ and Rose DeAngelis, Owner of Rosebud's Child Care and Learning.

Rosebud's Child Care and Learning is open 7:30 a.m. thru 6 p.m., Monday thru Friday. There is no extra charge for occasional lateness caused by unforeseeable circumstances (car accident, inclement weather). A phone call is appreciated. Frequent lateness is classified as more than one time per month and any lateness requires a late fee of \$10 per every 15 minutes past 6 p.m., which you should automatically add to your weekly tuition. We rely on computer or cell phone clock.

As the Parent, you are required to pay Rosebud's Child Care and Learning \$ \_\_\_\_\_ per week for full-time care five days per week. This tuition will not increase while this contract is in force. This contract will remain in force until day care ends or another contract is signed. I/We agree that payments will be made as follows:

**A full week's payment is due regardless of whether or not your child attends. When Parent(s) and Child go on vacation or are out due to sickness, full payment is required.**

Nutritious meals and snacks are provided to children eating table foods and drinking milk. Formula, baby food, diapers, wipes, diaper rash ointment, extra clothing and summer items (sunscreen, bathing suit, swimming towel, Little Swimmer diapers, water shoes) are not provided. The parent is required to provide them.

Rosebud's Child Care and Learning is closed for vacation two weeks each summer. Each year Rose McCabe will inform you of vacation time by March 1 of that year. The regular weekly payment is due for each week closed. Rosebud's Child Care and Learning is closed Good Friday, Easter Monday, Friday before and Memorial Day, July 4<sup>th</sup>, Friday before and Labor Day, Thanksgiving Day and the day after, Christmas Eve, Christmas Day, New Year's Eve and New Year's Day. Depending on when Christmas and New Year's Eve fall on any particular year, additional days will be added. Any additional days (at Christmas time or other) will be announced in writing at least two weeks in advance. Full payment is due for these holidays and/or closed days.

Parents of children attending daycare are not considered visitors. All other people coming onto the premises who have direct contact with the children are considered a visitor. Visitors must sign in upon entry to the premises indicating the date, time and purpose of the visit, and sign out upon departure. Visitors are monitored to protect the health, safety and welfare of the children in care and are not left alone with the children at anytime. All Parents are welcome to call or drop by unannounced anytime when their child is at Rosebud's Child Care and Learning.

Rosebud's Child Care and Learning will provide Parent(s) with a detailed statement of the previous year's payments for tax purposes by January 31<sup>th</sup> of each year.

Parent(s) give permission to Rosebud's Child Care and Learning to allow college students enrolled in Early Childhood Education to observe their child(ren) for learning purposes only. No names will be used in the college student's class work. These students will not be left alone with the children. These students must sign in and out on the Visitor's Log. Parents will be notified when a student starts.

Parent(s) give permission to Rose DeAngelis to use photos and/or video of their child(ren) for marketing and training purposes. No names will be attached with the photos. Photos will also be used in some crafts, which will eventually be sent home. We also have a secret Rosebud's Facebook page that you will be included in so you can see pictures of your children. Only current families are included in this page, no others can access unless you invite them (like an aunt or grandparent).

Parent(s) agree that they have read a copy of the Parent Handbook and Discipline Policy. Parent(s) agree that they have reviewed these and agree to their contents. Both are available upon request and on file at Rosebuds or found at [rosebudschildcare.com](http://rosebudschildcare.com).

Either Parent or Rose DeAngelis may terminate this Agreement by giving one month's written notice in advance of the ending date. Payment by Parent is due for the notice period, whether or not the child is brought to Rosebud's Child Care and Learning for care. Rose DeAngelis may terminate the agreement without giving any notice if the Parent does not make payments when due. Failure by Rose DeAngelis to enforce one or more terms of the contract does not waive the right of Rose DeAngelis to enforce any other terms of the contract.

By signing this Agreement, Parent(s) agree to abide by the written policies of Rosebud's Child Care and Learning. Rose McCabe may amend the policies by giving the Parent(s) a copy of the new or changed policies at least two weeks before they go into effect.
