**Motion** was made by Mr. Frick and seconded by Mrs. Hand to approve the minutes of the February meeting. All present voted in the affirmative.

**Reorganization:** Mr. Merlock's term ended and he didn't seek re-election. Ralph Bernard was elected to new 3-yr term and Elizabeth Hand was elected to a 3 yr. term. Mr. Walsh swore in elected commissioners.

Mr. Bernard was nominated for chairman by Mr. Walsh and seconded by Mr. Frick. All present voted affirmative

Mr. Walsh was nominated for Treasurer by Mr. Frick and seconded by Mrs. Hand. All present voted affirmative.

Mr. Frick was nominated for Secretary by Mrs. Hand and seconded by Mr. Walsh. All present voted affirmative.

Question was raised by Chief Hand concerning missing monies in Districts account. Stated Fire Company will help paying bills until monies are available by Fire District to resume paying of bills.

**Motion** was made by Mr. Frick and seconded by Mrs. Hand to close the public portion. All present voted in the affirmative. Closed at 8:10 pm.
