EVENT INFORMATION

The 2020 Summer Solstice Art Fair is very enthused to welcome artists to Lafayette Park for the fourth year. This annual festival, just north of historic C-Street features the Fine Art Show along with Music, Food, and History. Local residents and visitors from Southwest Missouri come to browse and buy from the artists in white tents, lined up along the brick promenade under mature trees. An exciting array of music and performances will add to the lively and fun atmosphere in the historic neighborhood park.

GENERAL INFORMATION

The juried Fine Art and Fine Craft show is open to artists and crafters in a wide range of categories and will be held in Lafayette Park, in the heart of the Moon City Creative District. There will be ample free parking for the artists either directly behind the tent space or very close.

AWARDS: The show will be judged and a total of \$1000.00 in cash prizes will be awarded for Best of Show, Best 2-D, Best 3-D, Best Booth and Jurors Choice.

MEDIUMS: This is a juried art show and all items sold in the show must be hand made by the artist and the artist must be present during the show. No more than 25 percent of work displayed may be offset prints, giclee and reproduced work and they must be clearly marked, and all photos must be signed and numbered. Artwork from kits or commercial means is not permitted. Artists may exhibit only artwork in the category in which they are accepted. Commercial agents, dealers, manufacturers or buy/sell vendors are not allowed in the juried art show.

AMENITIES: Artist amenities will include an attended , air conditioned hospitality building with snacks and restroom. Drive-up access, artist parking on site, lunch and refreshments. The show will be well advertised in all media (print, radio, TV, and Internet) and signage will be provided.

CANCELLATION: This is an outdoor show and will proceed rain or shine. Your accepted invitation and a final payment of booth fees is a commitment to exhibit and there will be no refunds for cancellations. Withdrawal must be written and delivered by mail or email. Acceptance is not transferable. Only artwork from the accepted artist may be displayed.

Artists are responsible for proper insurance and protection of work and set-up. MCCD or the Springfield-Greene County Park Board will not be responsible for damage to work or set-up for any reason (including Acts of God). Artists check in at Hospitality building at the west end of the park by 9:30 am
