City Council Minutes

May 4th, 2020

The City Council of the City of New Munich met in regular session at 6:30 p.m., in the City Hall. Jim Poepping, Shawn Duevel, Pat Nathe, Elmer Boecker and Ron Doll were present.

On a motion by Ron Doll, seconded by Elmer Boecker and carried the minutes from April 6th, 2020 were approved.

Fire Chief, Allen Fiedler was present to inform the Council of 3 medical call last month. Burning restrictions still into effect. The State gave the okay to go ahead with fire training with the pandemic. No bills for Al.

Waste/Water Operator, Tom Valerius was present to inform the council of one resident complaint of high water usage, Tom did a profile read. Baseball and cemetery water turned on. Sampling was done at NM Meats and monitoring of the wells. Well #6-east side, pumping a little slower, Wheels Water Service will be checking it out. McGuire Iron emailed regarding the water tower lining, the company is running a special for the pandemic, 3 year out warranty is included or a touch up on the liner. McGuire is trying to help the Cities with these services. Tom also noted the propeller that was ordered for a repair is 13 weeks out, hoping to arrive in July. Tom has a receipt for a new battery for tractor for the pump \$113.00.

On a motion by Ron Doll, seconded by Elmer Boecker and carried the following building permit was approved for Tim Klaphake, Worms Lumber & Ready Mix, Tim & Kelly Thielen

On a motion by Pat Nathe, seconded by Ron Doll and carried the building permit for Kurt Thelen was approved. Kurt attended the meeting.

On a motion by Ron Doll, seconded by Shawn Duevel and carried the annual renewal of tobacco license for Munich Hofbrau, Shady's Bar and Grill and New Munich Gas and Grocery were approved.

On a motion by Elmer Boecker, seconded by Pat Nathe and carried the annual renewal of liquor license (On Sale, Off Sale, Sunday) for Munich Hofbrau and Shady's Bar and Grill were approved. The Council also agreed on helping the bars out during the COVID pandemic and reducing the liquor license by \$240 for the 2 months they were closed.

Aimee Gerads, owner of the Munich Hofbrau will be having a special outdoor event on Saturday, June 6th. She will be using her catering license for this event; the alley will also be blocked off for this event.

On a motion by Shawn Duevel, seconded by Ron Doll and carried the approval of the financial statements from our 2019 audit.

We will plan on spraying weeds/fertilizing at City Hall and Park ourselves this year.

The council discussed the covenants for Munich Acres, the council will table until the next council meeting.

On a motion by Shawn Duevel, seconded by Pat Nathe and carried the approval to replace water tower liner, work to be done with Maguire Iron, Inc for \$42,200.00. payment will be carried the 2 years. Agreement/Contract was signed.
