'...''At the very least, they should have put the brand of a hot iron on Hester Prynne's forehead. Madame Hester would have winced at that, I warrant me. But she—the naughty baggage— little will she care what they put upon the bodice of her gown Why, look you, she may cover it with a brooch, or such like. heathenish adornment, and so walk the streets as brave as ever”...

...On the breast of her gown, in fine red cloth, surrounded with an elaborate embroidery and fantastic flourishes of gold thread, appeared the letter A. It was so artistically done, and with so much fertility and gorgeous luxuriance of fancy, that it had all the effect of a last and fitting decoration to the apparel which she wore, and which was of a splendour in accordance with the taste of the age, but greatly beyond what was allowed by the sumptuary regulations of the colony...

...But the point which drew all eyes, and, as it were, transfigured the wearer—so that both men and women who had been familiarly acquainted with Hester Prynne were now impressed as if they beheld her for the first time—was that SCARLET LETTER, so fantastically embroidered and illuminated upon her bosom. It had the effect of a spell, taking her out of the ordinary relations with humanity, and enclosing her in a sphere by herself...

... In Hester Prynne's instance, however, as not unfrequently in other cases, her sentence bore that she should stand a certain time upon the platform, but without undergoing that gripe about the neck and confinement of the head, the proneness to which was the most devilish characteristic of this ugly engine. Knowing well her part, she ascended a flight of wooden steps, and was thus displayed to the surrounding multitude, at about the height of a man's shoulders above the street...'

Dear Inspector General Griffin,

Dear Inspector General Griffin,

I just submitted an online complaint regarding Ronnie Austin Sr and Richard Owen Flamm (FWC Tampa). Since only one attachment was able to be included, I am including all of my information here as well.

From my online complaint:

'Varied locations. Throughout years, ongoing. I saw Flamm in Miami at least twice - at Pinecrest Market when I was handing out pocket Constitutions (10.15.17) and at my father's 1 yr date of death (2019, at the Miami cemetery). Police report filed on the latter and police informed of the former. In both instances Flamm made himself seen by me and hurried off (to his car at the cemetery). Numerous other instances, locations of concern in the att Docket 126."

"I do feel that Richard Flamm has been involved in retaliation against me. Ronnie Austin had asked me (via phone), "Don't you think [Flamm] was mad at you"? Now, this was quite a shocking response, since Law Enforcement, OIG's, etc. are supposed to uphold the law, and not facilitate crimes. In thinking back, I believe I said something like, "I assume he follows the Constitution", but may have been too shocked to say anything. Austin's statement means even more now that I have detailed records going back years. What exactly did Austin mean by that? Not too many ways to interpret it, really. I have included a recent letter to Fairchild Volunteer Board (Docket 142). See also "Notes 5.3.24" and "More detail 5.3.24". Docket 142 details current remote technology that has been used to harm and kill (ex. Havana-Syndrome). I do believe, for a number of reasons, that Flamm and/or people he knows have access to this tech and are using it on certain "Targeted Individuals". Expert testimony in these regards is linked to in the Docket. (As only one att is accepted I will email the Dockets.) I am glad to send any other requested information.'

Dear Dr. Lewis, FOF Board, and Fairchild Staff members,

I wanted to clarify and further explain my comments regarding “targeting” from our last FOF Board meeting 10.11.23. Please note that my documentation below is very concerning. I would hope that others with knowledge of such serious matters would also share it. I have no doubt many would say I have an obligation to tell others. This information has been kept from the public; the technology aspect of targeting is acknowledged by the military and known by the government. See transcriptions and lectures from Dr. James Giordano, neuroethicist, linked at the end of this letter – he teaches this technology to students at West Point, Naval Academy, etc. See also the link to Dr. John Hall, anesthesiologist in Texas, who is a “Targeted Individual” (TI) and discusses his and his patients’ experiences with both the technological assaults as well as physical stalking and harassment.

Read this letter, or not, as you wish. However, if you do read this, I think you will appreciate that you have been informed. Concerns involve our organizations, including Fairchild, University of Miami (UM), and Miami-Dade County, with UM complicit (more below), and the County likely as well - knowledgeable at the least. There are funding sources that would find “targeting” repulsive, and to me, what Fairchild stands for is indeed antithetical to this barbarous practice. Below I have a small amount of my total documentation that has been submitted thus far to local and other overseeing authorities. This includes some of my reporting as well as links to transcripts and videos of expert testimony, including Giordano, a Pentagon Advisor and Georgetown Professor; Dr. Robert Duncan, ex-CIA/Harvard tech developer now whistleblower; Julianne McKinney, Army Intelligence Officer (deceased); and Dr. Hall. The latter three are TIs. I am always glad to answer further questions and share more documentation.

Unfortunately, many universities are of utmost concern in these regards. Yes, they do important scholastics, outreach, and work for the community, but there is a much darker aspect. I worked at UM for twelve years and my concerns are based on the history of illegal experimentation associated with universities (more below), direct knowledge, and impressions. UM has no oversight to speak of (verified in emails with the State), in large part because they are private. They have also housed the second largest CIA hub for decades. Scarier than UM having questionable oversight, is the fact that the CIA basically oversees their own programs. Everything is “secret”, and only a few know the “projects” the CIA is working on at any given time. At the links (Church Committee, MKULTRA) on the next page, you will see that these “projects” have included horrid acts of human medical “research” associated with universities. I believe I assume correctly that UM’s impunity in these matters I describe is facilitated by their association with the CIA. Would UM have committed Medicare fraud, etc. regardless? Probably. However, the barbarity I describe absolutely speaks to something much more sinister and entrenched.

One of the matters I report here is CIA technology being used against the public (see Duncan, others below). There is a lot online about targeting and Targeted Individuals. At our last FOF Board meeting, in briefly speaking about people maliciously infiltrating our US organizations (not the words I used then), I suppose the term “agitator” is appropriate in some respects. I did not use that term but that is what was in the meeting minutes (att). I had said that outside entities are in our organizations and targeting people. I gave examples of my American Legion local and of the current Senate hearings regarding targeting by the FBI. <https://www.washingtonexaminer.com/news/house/watch-live-house-weaponization-committee-holds-hearing-with-three-fbi-whistleblowers>. Also, Chris stated “politics” is not appropriate here – I told him this was about the Constitution, not politics. Strangely, his comment

2/9 - was exactly the same as my local Legion Chair's when I brought up the Constitution there, although in that case, up-holding and defending the US Constitution are the Legion's primary stated purposes. Part of my Legion complaint in those regards is below.

These entities are much scarier than "agitators", as you will read below. They also deliberately insert themselves in most, if not all civic and social organizations. These people are actually rogue elements of our intelligence apparatus and their proxies, and appear to want nothing less than to overturn the Constitution (more details below). To me, this is treasonous, and I prefer much harsher terms for them. Much of my documentation here has been submitted to MDPD and/or their overseeing entities as well as filed with the Courts, including the experiences I have listed below, expert testimony, and many of these links. This is a minute amount of all my personal documentation, and I am glad to share more upon request. My apologies that this letter is a bit lengthy, but I did want to include parts of submitted reports that involve some of these concerns.

I wish the above referenced Senate Committee investigating FBI targeting (Subcommittee on the Weaponization of the Federal Government) was more like the 1975 Church Committee, but it is a very revealing process none-the-less. The FBI has a long, sordid history of Stasi tactics. The FBI's COINTELPRO program goes back to Hoover. This "Counter Intelligence Program" against Americans included following and otherwise surveilling, eavesdropping, blackmailing, blacklisting, compromising, and killing people who questioned government policies, were whistleblowers, incorruptible, etc. That mentality and methodologies never ended, and they are being investigated for the same types of crimes now. <https://en.wikipedia.org/wiki/COINTELPRO> "...While COINTELPRO was officially terminated in April 1971, domestic espionage continued..."

Rogue in these same intelligence agencies continue to “work” at the behest of the powerful. Here in Miami that includes the University of Miami and I believe as well, high-level County officials. Even Miami-Dade Police (and other police nationwide) are compromised as they are forced to be complicit in targeting by ignoring complaints, “looking the other way”, etc.; a vile situation they likely have no choice about (see Duncan, Hall, McKinney below). Of concern as well is that MDPD appears to be doing all it can to thwart any oversight, something we should all demand they, and all law enforcement, must have.

The **Brennan Center** and **ACLU** have written excoriating reviews (see online) about the “**Fusion Centers**” in every state. These centers were set-up after 9/11 to allow access to all our personal information, by all law enforcement, including the FBI. This system continues to be used in abusive and illegal ways as it is **without sufficient oversight, checks/balances, need to know**, etc. Furthermore, targeting is facilitated as target names are often flagged statewide, with their complaints to police and medical going nowhere to avoid further investigation of these illegal activities. (More on this a few paragraphs down including the Targeted Justice lawsuit regarding **illegal and secret listings of whistleblowers, those uncorruptible**, etc. under certain codes in the FBI’s **Terror Watchlist**. When I worked at UM as a Tumor Registrar, I reported cancer data manipulations in violation of State law. The department manager, Stuart Herna, threatened me because I had “complained about a lot of people”. (I reported this threat to City of Miami Police.) A lead UM worker, Susanna Arias Morales, also told me pointedly that she had a “relative in the FBI”. I was fired after twelve years there when I reported that threat by Herna in my response to a good evaluation and offer of an approximately \$10,000 raise. I believe no one is above, or beneath the law, and am still reporting these horrifically unconstitutional actions that continue to this day - and am still being retaliated against for doing so. Just below see examples of heinous actions UM is capable of, without a second thought. I am currently seeking due process and justice (terms not in the vocabulary of these perpetrators) for all involved, for all our sakes.

So that you understand the depths of the depravity I am referring to, this is an excerpt from a letter to an overseeing entity regarding the hospital murder of my cousin, I believe in retaliation for my reporting Herna and UM to the Joint Commission: “... *The emails using military terminology to timeline the murder of my cousin, Joan Myers (Joan M), at Bethesda East are in Docket 101 (and other documents) as well. I saw Joan within the week of her murder and she was not imminently dying of anything. She had a chronic illness and this sudden weakness may have been caused deliberately to get her in the hospital (she had no security cameras at her apartment). She would travel a few times a year to UM/JMH in Miami for follow-ups. The date of her death was again a very common one mentioned in my reporting. Furthermore, I was a Tumor Registrar for 12 years (at UM), detailing medical histories including end-of-life. Joan was up, walking, and couldn't wait to go home; most of us would have known Joan was not in her final days (naturally). Of course, her medical chart will have false information. Unfortunately, it seems such manipulation is not at all uncommon. At the end of this email I have a list of some of these related links copied from my website: nonprofit, nonpartisan ourconstitution.info, the Medical-Military link under the Home tab. Others like Joan - poor, un/under insured, etc., are prime targets. Hate and retaliation are other reasons for these killings regardless of age, financial/insurance status, etc.*

4/9 - Joan's MD at Bethesda (apparently a UM medical grad) convinced Joan's next of kin (up north) to donate her cadaver to UM even though Joan's parents had years ago purchased a plot for her near them. I did not know she was sacrificed as a cadaver until after the fact, and had asked those relatives to get her out of there while she was alive. (I had reasons for concern and had filed a police report with Boynton Beach before I went to visit her.) In hindsight, I again see that more time, money, and resources from our "trusted" institutions were spend to maliciously plan all the aspects of this horror. As I have documented, including in the 24-pages sent last time (I will send/resend any/all requested), I realized the malicious capability of UM, their collaborators, and this medical-military (after Eisenhower), but Joan sounded even better when I called a few days after visiting, and I felt reassured. As evil as I know these entities are, I still wanted to feel they could not go that far, be that sadistically obvious... But that's who they are. UM loves to not only shock and appall, but entrap and/or compromise anyone they can. They truly savor it all. I later learned that Joan was also illegally in restraints when I had visited her, the restraints being reapplied whenever she got back in bed. This was so obvious, that as concerning as it was, I thought it must be legal. I realized it was not legal when UM later sent me a training on restraints after her death, as part of that year's job requirements. I never had a restraint training before that (in my 12 years there), and never needed one as I had no patient contact. This is one more indication of just how vile they are. I am mainly speaking of UM in these regards, but the retaliation against me escalated after the State completed its "investigation" into the cancer data manipulations I had reported as a UM employee..."

Although the CIA is supposed to "work" overseas only, UM and their CIA tenants illegally do each other's bidding. I have documentation of this used as retaliation against me (for reporting UM in another matter). The CIA is also infiltrating multiple entities of our society. The photos of media enclosed at the end of this letter name multiple professions CIA assets "work in" (in reality, this likely includes all professions) as well as noting that they also likely infiltrate all media and civic organizations. I also include there an ATT email that was responding to my phone unlock request. Please notice that I am referred to as "Judas". (I have also had my UM and personal email hacked, my phone hacked, and bank alerts turned off. I have reported much lost, "delayed", and opened mail via USPS and UPS, mainly regarding legal matters.) Unfortunately, as a Jew, very bad Jews (and non-Jews) are involved in perpetrating these crimes – and there is certainly no "Jesus" among them. UM likes to appear as an upstanding entity and involve themselves in local affairs, and many of their employees are indeed fine individuals. Unfortunately, their very bad elements act with impunity, compromising others, and often retaliating against anyone speaking up for what is right or who otherwise disagrees with them.

The links I sent with my email to this Board on 7.12.23 mention neuro-targeting – something both the CIA and FBI are involved in. (Neuro/energy targeting is a continuation of MKULTRA, mentioned above, and has been used against the public for decades. See links to Duncan, Hall, and McKinney below.) The tech is CIA in part (see Duncan) administered via the US military.

5/9 - **lawyers, engineers, other professionals, homemakers, and children. None are terrorists and would not fit that definition.** In fact, most targets are often whistleblowers, uncorruptible, etc. These people are referred to as **Targeted Individuals** and there is much online about this horrid harassment worldwide. Targeting is deliberately not in major media so that the public is unaware, and continues on.

As mentioned above, these rogue perpetrators abhor the Constitution and rule of law. Due Process is not in their vocabulary. Clearly this is something we should all be concerned about, especially as these powerful entities undermine investigations into related complaints by those targeted, including to police, medical, etc. This scarily appears to be a very high-level, dangerous coup in progress, threatening everything we stand for, and that those we love, have fought and died for. Next below, in quotes, are paragraphs from an email I sent to American Legion National offices in March of this year (as well as to oversight agencies). I had brought these concerns to the members of my Local because the American Legion and their Auxiliary Constitutions both state as their first listed purpose: "...uphold and defend the Constitution of the United States of America...". I asked that we have five minutes to speak on these and other concerns regarding the Constitution at our monthly meetings. Although I know others agreed with me, much like on the recent FOF Board vote for all plants to be free at FOF meetings, no one else voted for these five minutes regarding concerns for the Constitution, Our Rights, and Freedoms. Our Legion meetings are largely spent planning fund-raisers involving food and alcohol served at the Local.

From my March 2023 letter emailed to American Legion National: "...These various "irregularities", "errors", contradictory statements, etc. I reported have been ongoing now for a while. If you do share this note with Linda, please cc me as well. I thought it weird that she changed the 5 to 15 minutes, and I recalled that I had mentioned (in email) my motion to you, including the 5 minutes. Perhaps she told you I had said 15 minutes? It may be prudent to have Legion investigatory staff know about this (or a hired investigator) and indeed find out who is involved, and ideally have the perpetrators arrested. Someone is using Nancy's identify as a Legion member to send letters, for one. That sounds like at least two Federal crimes. Someone is also "encouraging" this taunting and deliberate maliciousness - coercion is the more appropriate term - regarding my statements at meetings, (lack of) response to email/other questions, birthdate I believe as well, perhaps emails to the group not being sent to me, and desire to expose these concerning matters experts have testified to. I certainly hope these actions do not rise to the level of collusion on the part of Legion members. I do believe (most of) these members are likely scared by these elements, and the evil they represent. As mentioned, these situations are not unique to the Legion, but they are part of a well-documented pattern, ongoing years, with much similar and worse substantive, horrid details submitted to police and the Court..."

Elsewhere in that March letter I include an email I had sent to our Local. In part: "...One topic I would like to see on the Agenda is discussion regarding the Legion, the US Constitution, and a few related matters. Legion and Auxiliary Constitutions both state as their first listed purpose: "...uphold and defend the Constitution of the United States of America...". Please note, this purpose is regardless of any politics or party a member may belong to. (The Constitution belongs to, and must be upheld by, all of us.) In fact, further down on both Legion Constitutions, in Section 2, they both state, "The American Legion [Auxiliary] shall be absolutely nonpolitical and shall not be used for the dissemination of partisan principles..."

The reason I mention this is that it appeared to me that because I hand out pocket US Constitutions and/or have a website called ourconstitution.info, one or more Legion members have felt that I was conservative leaning (perhaps assuming Republican). More than once I have brought up this topic at our meetings to be told, "That's political and we are not political" or "We don't do politics", (or similar). I did respond that this is not politics, it is the Constitution. I also mentioned that I am nonpartisan. Just FYI - I registered as a Democrat since I began voting (this is online also) - but find the parties to be dividing us

6/9 - deliberately. I refer to them as our vicious duopoly, and have voted for both. Washington hated parties, so I'm in good company. Unfortunately, it seems one may lose out on chances to vote in primaries if registered independent, so I have not changed parties. It seems we would be better off to get rid of them and just use our names.

Just to clarify - I did not know anyone's political affiliation here. However, at the last meeting when I mentioned my concerns again for the upholding of the US Constitution in society - someone got up and left before I could even finish my sentence. I have been polite to this person, even defending her stand on money allocation although I do not know her to speak of. I had listened to her point of view and thought her concerns were valid. It was after that last meeting that I began to believe that some here operate as do many in society - equating organizations that have the word "Constitution" with conservatives. Obviously, some were not listening to me, did not want to listen, and concerningly seemed to be just trying to shut me down. Regardless of party or politics - there are entities who foment the concerns I have documented, and absolutely want these "practices" to continue..."

information and will provide a comprehensive anti-terrorist list when a suspected terrorist is screened or stopped anywhere in the federal system.” **Exhibit 8** (Emphasis ours).

23. Despite the clear and limiting text of HSPD-6, Defendant FBI has admitted that the TSDB contains names of people with no ties to terrorism. In a statement given under penalty of perjury in *Elhady v. Kable*, 391 F.Supp.3d 562 (E.D.VA 2019), *rev'd* 993 F.3d 208 (2021), former TSC Deputy Director Timothy Groh expressed that the TSDB contains information of individuals who constitute “**an exception**” to the “**reasonable suspicion standard**” “**who are not considered ‘known or suspected terrorists’**” and “**are not screened as such**”. (**Exhibit 2** - Emphasis ours).

24. Groh’s specific words (**Exhibit 2**) were the following:

“Additionally, the TSDB includes identifying information of certain individuals **who are not categorized as known or suspected terrorists.**” (Emphasis ours).

³ Additionally, the TSDB includes identifying information of certain individuals who are not categorized as known or suspected terrorists. These limited exceptions are more fully described in FN 7.

“Limited exceptions to the reasonable suspicion standard exist for the sole purpose of supporting certain screening functions of DHS and State (such as determining eligibility for immigration to the U.S.). **Individuals included in the TSDB pursuant to such exceptions are not considered “known or suspected terrorists” and are not screened as such.** As a result, any U.S. person who is in the TSDB pursuant to an exception to the reasonable suspicion standard would not be required to undergo heightened aviation security screening at airports on that basis but could be selected for other unrelated reasons such as random selection.” (Emphasis ours).

⁷ Limited exceptions to the reasonable suspicion standard exist for the sole purpose of supporting certain special screening functions of DHS and State (such as determining eligibility for immigration to the U.S.). Individuals included in the TSDB pursuant to such exceptions are not considered “known or suspected terrorists” and are not screened as such. Pursuant to Fed.R.Evid. 201(c)(2) and (d), Plaintiffs request that this Court take judicial notice of the adjudicative facts contained in **Exhibit 2**, and specifically the statements cited above.

25. The names of NIS who are not "known or suspected terrorists" (KST) appear in the

"Handling Codes 3 and 4" subcategories of the TSDB that constitutes 97% of the identities in the entire dataset. (Hereinafter: "TSDB NIS McCarthy blacklist"). Hence what Groh called "limited exceptions" to the KST listed in the database really constitutes the norm. See paragraph 156 below.

26. Even though seventeen of the eighteen individual Plaintiffs and TJ Members are American citizens and one is a legal resident, none meet the terrorist criteria. Only 1 – the legal resident—could be conceived as subject to "special screening functions of DHS and State". Defendants FBI, Wray, and Kable and their predecessors illegally and under color of law and/or in an abuse of discretion included and/or maintain Plaintiffs' names within the TSDB NIS McCarthy blacklist despite the lack of derogatory information linking them to acts of terrorism.

27. Defendants FBI, Wray, and Kable, acting under color of law, have disregarded their oath and obligation to adhere to the limited scope of HSPD-6 and to uphold the laws and Constitution of the United States. Instead, they have secretly included in the roster of the TSDB hundreds of thousands of innocent NIS or US Persons such as Plaintiffs and TJ Members that do not meet the terrorist criteria.

28. In the exercise of their official duties and acting under color of law, Defendants Wray and Kable abuse their discretion and violate their oath and the Constitution by illegally deciding upon the fate of unsuspecting individuals such as Plaintiffs and TJ Members and including them in the TSDB even when they do not meet the terrorist criteria.

29. By including Plaintiffs' and TJ Members' names in the secret non-terrorist McCarthy blacklist embedded within Handling Codes 3 and 4 of the TSDB, Defendants FBI, Wray and Kable, acting under color of law and under the guise of "national security", have secretly, unconstitutionally, and maliciously sentenced the former to undergo a lifetime of covert human experimentation that targets and tortures them in many instances to their death.

156. According to Defendant FBI, Handling Code 3 comprises Individuals with ‘Possible Ties to Terrorism’.


157. Pursuant to Defendant FBI Handling Code 4 comprises people whose “Identity Provided has Possible Ties to Terrorism”.

158. Defendant FBI, Defendants Wray and Kable know that people included in Handling Codes 3 and 4 do not meet the terrorist criteria yet under color of law continue to illegally maintain Plaintiffs hostage under those categories in open violation of their constitutional substantive and due process rights.

159. In so doing, Wray and Kable acting under color of law add non-terrorists to the TSDB with the purpose of secretly adding human experimentation subjects to “the Program” and submit them to a lifetime of illegal surveillance and torture.

160. On information and belief, the individuals included in the TSDB who Mr. Groh stated “are not considered KST and are not screened as such” are also referred to as NIS are grouped in the categories labeled as “Handling Code 3” or “Handling Code 4”.

161. On information and belief, for every KST listed in the TSDB, there are 334 NIS non-terrorists listed in the TSDB. United States Department of Justice (“USDOJ”) Audit reports of TSC operations carried out in 2005 and 2007 revealed that their sampling of the TSDB revealed that only point twenty-nine percent (.29%) of its records belong to KST.



162. Pursuant to Defendant FBI, NIS listed in the TSDB’s Handling Codes 3 and 4 do not meet the “reasonable suspicion” standard, are not considered “Known or suspected terrorists” and “are not screened as such.” **Exhibit 2.**

163. Handling Codes 3 and 4 constitute 97% of the TSDB and (a) include a pool of individuals that don’t meet the KST criteria and (b) are victims of an illegal McCarthy blacklist maintained for illegal purposes.

164. Former TSC Deputy Director Timothy Mr. Groh stated under Penalty of Perjury that “any US person who is in the TSDB pursuant to an exception to the reasonable suspicion standard would not be required to undergo heightened aviation security screening at airports on that basis.” See **Exhibit 2.**

165. Since NIS such as Plaintiffs do not represent a real terrorist threat, they do not face undue hardship or heightened scrutiny when traveling to alert them about their TSDB status.

166. NIS’ lack of travel obstacles is precisely the reason why only two Plaintiffs, Calvert, and Stewart, have become aware that their names had been included in the TSDB NIS McCarthy blacklist.

167. Defendants FBI, Wray and Kable failed their legal obligation to Plaintiffs and TJ

the TSDB but only 5,000 (0.5 percent or one two-hundredth) of them were Americans.⁶

227. On September 2014, Transportation Safety Administration's Christopher Piehota testified before the House of Representatives' Subcommittee on Transportation Security that by 2013 the TSDB had 500,000 records and in 2014 the list contained 800,000 identities.

228. Mr. Piehota's testimony confirmed that an estimated 300,000 additional records were included in the first 9 months of 2014 for an average of 33,333 new individuals added to the TSDB per month.

229. In 2014, Mr. Piehota testified that the 8% of the 800,000 identities in the TSDB -- or 64,000-- were in the "No Fly List" or Handling Code 01.

230. Conversely, a 2005 USDOJ audit of FBI's intra-agency operation TSC stated that .29% of the identities in the TSDB belong to KSTs.

231. Thereafter, former Defendant FBI TSC Deputy Director Timothy P. Groh stated under penalty of perjury in *Elhady v. Piehota*, 303 F.Supp.3d 453 (2017) that there were approximately 1.16 million persons in the TSDB and that only approximately 0.5% (fewer than 5,000) of those were US persons.

232. On March 11, 2019, Defendant FBI former Deputy Director Groh declared under Penalty of Perjury that US persons (citizens and lawful permanent residents) make up less than .5 percent (i.e., one two-hundredth) of the identities in the TSDB. (Exhibit 3, page 5, ¶ 14).

233. The vertiginous increase in the number of people included in the TSDB reflects Defendant Wray's and Defendant Kable's and their predecessors' failure to protect "the freedoms, privacy and civil rights of U.S. persons and other individuals with rights under US law." Exhibit

Strange circumstances regarding probates of family friends, I was involved with Bea Van Welde's and there were unethical/illegal violations and seeming coercion involving the attorneys;

What did Paulvil do with that video of mom's burial? Rebecca Butler Clark with photos of a family get-together? Why did Flamm make himself known to me at dad's 1-yr date of death, down from Tampa, at the cemetery? What was Flamm doing at Pinecrest Market same date and time as Larry Schokman's death (and while I was handing out my Constitutions he walked right by my table saying not a word)?;

81, 82 – American Legion fraud use of their insignia/name of hospitality chair (ID theft) to send me harassing mail appearing to come from them/coercion of Legion members/USPIS

83 – Emails with Montgomery Township Police Best Buy account social security fraud

97 – Emails USAO; MDC SAO – covering-up all complaints related to mom's "care" with Griswold, Children and Family Services, Baptist, what the Joint Commission report stated

98 – Emails with MDPD - re: false police report filed, other MDPD concerns facilitating targeting, Lt. Ottley's role, etc. (More reports and complaints are filed with MDPD. Facilitating the cover-up of my complaints.)

5.3.24 Judith Futerfas 4pp 2 documents recent overview, timeline; names, descriptions

Another disgraceful, more recent event was an illegal FIU trespass that was quickly rescinded by FIU General Counsel. FIU is affiliated with Fairchild and I have included that FIU email here as well. I am an alumnus of FIU. Briefly, what happened: I went to buy a t-shirt at FIU and did not know classes were out. It was quiet but I thought maybe the stores were open. I returned to my car and left within ten minutes. The reason written for the trespass was that I had complained to the FIU Board of Trustees three years prior (yes, because I had complained, and yes, three years prior) about an ex-FIU advisor, Dr. Richard Owen Flamm. I think the REAL reason for the fraudulent trespass is because earlier that month (July 2023) I had filed in court a detailed document outlining this decades-long history of harassment and retaliation. Just to reiterate - these sanctioned illegalities are funded with our tax \$\$... Flamm was named in my filing(s), along with Susan Markley, a University of Miami (UM) PhD grad. Several at UM also were reported. Markley worked at MDC's DERM and chaired the Manatee Action Group, where I met Flamm about 2000 or so. Flamm did not work for FIU, but Florida Fish and Wildlife (FWC) out of Tampa. I have suspicions he (and Markley) worked for at least one other (ABC) or related agency as well. In any event, they were unsuitable to work with students. (Markley at one point told me students were taken away from her.) I do believe full disclosure to students as well as the school is warranted regarding connections to intelligence and one's suitability otherwise, PRIOR to any decision regarding school and student affiliations. (I have known fine people working in intelligence but in general the abuse and illegal surveillance now, as detailed in the FOF letter, is out-of-control.) A bit more detail follows below for those interested.

Please note that I was enrolled at FIU to about 2003 and worked at UM from about 2008-2017. This retaliation has been going on since I was at UM, with much documentation by me - dates, locations, names, circumstances - since. Flamm is absolutely involved and the seeming rogue attitude and sense of entitlement (above the law) by all involved is extremely concerning. FWC OIG's Ronnie Austin asked me if I thought Flamm was "mad at [me]". I presume this was because I did not get Flamm a brief paper - though he did get the massive amount of data I collected (for him)... Flamm had told me at one point he did not want a paper (because there were two speed zones). He clearly seems to have been "influenced" by others. I have asked that my FIU degree be taken back, to no avail. Same with trying to take Flamm's information off my thesis (I had been very thankful to him). My thesis is hosted online via FIU and I even told them they could keep it up under either situation.

As you probably know, I believe "intelligence" agencies should be off our campuses. (Tell that to UM and their 2nd largest CIA hub!! Really. Tell them and the community.) That connection is probably not realized by most people - I think many more would disapprove. (I know for a fact that UM used any resources they could, including the CIA [details court filed], to retaliate against me, likely for reporting cancer data manipulations and other matters. See 9-page FOF letter att.) I will add that Susan Markley also hosted the 2009 Miami-Dade County Manatee Protection Plan Review Committee (MPPRC). Carlos Alvarez was Mayor then. He is an FBI Academy graduate as well as former MDPD Director ('...a group of policemen who served in the department described his management style as marked by "favoritism and retaliation" ...Alvarez was recalled after complaints of tax and selective pay increases...' [https://en.wikipedia.org/wiki/Carlos_%C3%81lvarez_\(American_politician\)](https://en.wikipedia.org/wiki/Carlos_%C3%81lvarez_(American_politician)))

(UM's Susanna Arias Morales, as attempted intimidation, among other actions and comments, also told me that she had a "relative in the FBI".) I was on that MPPRC, and noted publicly (on video) that several members stood to financially profit from certain votes. They were land owners on the Miami River and did indeed vote regarding boat docks (and all else). I think I was greatly NOT appreciated for that

comment, much like when I sent the 9-page letter to FOF. (My initial, very brief email to FOF Board in these regards was sent 7.12.23, DAYS PRIOR to the illegal FIU trespass.) I do believe the retaliation against me goes back to my time on that Committee and while at UM, and that Alvarez, Markley, and UM are possibly even more culpable than Flamm. Ronnie Austin (now retired), certainly has some role...

I wrote my Student Bill of Rights more recently (below), as there apparently is none. Anyway, several of the people I have mentioned should likely be arrested if anyone knows anyone with enough ethics and the power to do so. Seems a rare combination. My detailed and documented complaints, court filings, etc. (regarding the above and many other matters as concerning and more so than the illegal trespass) to MDPD and their oversight panel have been ignored. How reassuring.

My Student Bill of Rights from the cover of my book, "Humanity's Abyss...":

There is no standard US Student Bill of Rights.

Laws and/or regulations must include:

*All People working with one or more Students, in and/or outside of the academic institution(s) and regardless if these institutions are public and/or private, or any other combination of designations, must be vetted, abide by the US Constitution.

**All People working with one or more Students must fully disclose to these Students and the academic institution(s) any and all Intelligence related work and/or activities, paid or otherwise, for the US and/or all other entities.

5.3.24 Judith Futerfas 2 pp More detail, names

These matters are very serious Civil Rights, Due Process, and Constitutional Law issues. Most of them are not directly related to my mother's probate. These concerns involve all levels of government, from local to federal. My data is quite detailed and comprehensive - names, dates, locations, circumstances, documents, etc. I know who knows more about the main perpetrators (besides the names listed below). A description of many of these concerns is listed by Docket number, filed as Docket 126 in my mother's probate. These matters are so concerning that I wanted them filed to preserve the information. Some of these concerns do regard my mother and the probate, but the majority are other matters just as serious and even more so - including and along the lines of concerns described in my Fairchild letter (Docket 142).

... As examples of the seriousness of what I have reported...who told FIU's Chief of Police Casas...to give me the fraudulent trespass (rescinded soon thereafter by FIU GC)? Who told him to send two FIU Police and two MDPD officers to my apartment to warn me not to report an ex-FIU advisor, Richard O. Flamm (a Florida Fish and Wildlife employee out of Tampa), further? What was Flamm doing in Miami, at the cemetery where my father is buried, on his one-year date of passing? Flamm made himself known to me

(walking out from an area several yards in front of me) as we were going back to our cars. He rushed to his car, also some yards in front of me, and left. I filed an MDPD police report. Also, why was Flamm at Pinecrest Market - ensuring I saw him, walking past my table with my pocket Constitutions, not saying a word, and leaving? I also told this to a City of Miami Police Detective I was communicating with. (I began reporting to the City of Miami Police after my University of Miami [UM] boss Stuart Herna threatened me, stating that I had "complained about a lot of people". I worked at the Medical Campus. I was fired after reporting that threat in my response to a good evaluation [for the prior year when the threat was made] and an approximate \$10,000 raise.) Who told Flamm to do these things? Who told Herna to threaten me? I had mentioned a bit more regarding UM in my Fairchild letter, but have much more reporting on them. More concerns are also briefly described below, a few of MANY. All with much documentation filed, including pertinent emails.

As another concern, who told Secret Service agent Paul Adie to stop assisting me? He was very helpful regarding the hacked emails timelining my cousin's death (the circumstances of this murder were mentioned in the Fairchild letter). That seems like something the FBI would have the "pull" to do. Who is UM's Susanna Arias Morales' "FBI relative" (as she pointedly stated to me when I worked there)?

Who spoke to my American Legion Chapter President and told her to distort my comments stated at a meeting (she wrongly notated them in the minutes, which were also reported to American Legion National)? Who told her to try to obfuscate the fraudulent mailed "birthday cards" (x2) to me that appeared to be from our Legion Chapter Hospitality Chair according to the return label (but were not - proof of different hand-writing also sent to National - cards sent in December - my birthday is February)? This was reported to the USPS (as referred by the FBI). I have yet to hear back from them, the FBI (regarding other concerns), MDPD, etc. (Some of these concerns may sound less serious, but there is nothing benign about them.)

Besides fraudulent senders of mail, who is interfering with my mail delivery, including certified, registered, UPS, and USPS?

Who instructed the person in Pennsylvania to falsify the first three numbers of her social security so that it then matched mine? Who instructed her to open a Best Buy account (in Pennsylvania) using my social? Who instructed her (or whomever) to then make a payment for MORE for than the cost? Who instructed that these transactions were to be on these particular dates and for these particular amounts (coinciding with other matters)? I reported this to the FTC (per FBI instructions). Still waiting to hear back from them. Why are the police in Pennsylvania, referred to by MDPD, saying this was all a "mistake"? I learned information about the perpetrator from the bank and Best Buy. From my email with that Pennsylvania police department:

Why is MDPD (nor their ICP/oversight) not investigating ANY of my complaints (much documentation of this and of all my MDPD communications via email), nor rectifying a police report that two Internal Affairs officers acknowledge is false?

Who was instructing whom at the Miami-Dade Court to delete my hearing request confirmation dates re: mom's probate? I began to photograph and file (in the Docket) the hearing confirmation page. I emailed these and other concerns to Judges Colodny and Sayfie (Docket 118), to no avail. Who caused the certified mailer of notice of mom's first probate hearing to be late - delivered to me the day prior to the hearing? Who stopped my Registered and Certified letter from reaching the Miami-Dade Mayor? Who interfered with USPS and UPS certified mail regarding a legal matter (probate) in Bradenton? Who interfered with that probate to greatly skew the settlement amount, including granting money to a relative whom the decedent (a family friend) had deliberately left out of her Will? Who told an attorney there to lie and say that all had agreed with the settlement, when they had not?

The names mentioned here are but a few of those with more information. Of course, UM's Herna, Arias, and others there also know quite a bit, as do some of my parent's aides. I filed a police report (Docket 46) regarding my mother's aide Marie Paulvil. She was horrid, and knows quite a bit. I think she thrives on evil. ALL the information I mention here has documentation in the Docket, including my \$10,000 raise letter from UM; my complaints to my parents' aide agency; complaints to the Joint Commission re: UM, Bethesda (my cousin), Baptist (mom); complaints and concerns to MDPD and their oversight; and emails to OIGs, AGs, IGs re: UM and related concerns. I also reported to the DOJ (the FBI) and US Attorney, all to no avail. I visited Senator Nelson's office while in DC and communicated these concerns via email to his staff. Nelson had referred me to Rubio with my concerns, and Rubio supposedly sent them to the FBI. However, the FBI did not appear to investigate and continued to cover-up, even while I was in DC. Nelson's office had referred them to help me and I spoke with them via phone from his office - and they initially were concerned. Then their attitude changed, and I even walked over to their offices and they had me stand on the sidewalk, away from the entrance door. I was requesting information on what they had learned in these regards. They remained silent. I have a lot of other very concerning information in my filings, indisputable - much clearly illegal and the rest suspicious, at the least.

I, Ted L. Gunderson, hereby swear under the pains and penalties of jury that the following statements are true and correct:

1. My name is Ted L. Gunderson. I am the owner and operator of Ted L. Gunderson & Associates, an international security and consulting firm based out of Santa Monica, California. I am currently a licensed private investigator in the state of California. I have performed private investigation and security work for numerous individuals, companies, and governments worldwide since founding my firm in 1979. I have worked for, amongst others, F. Lee Bailey, Esq., The California Narcotics Authority by appointment of Governor Jerry Brown, The 1984 Los Angeles Olympic Committee, and The 1979 Pan American Games in San Juan, Puerto Rico by appointment of then U.S. Attorney General Griffin Bell.
2. Previous to my work as a private investigator I spent nearly three decades in the F.B.I. Between 1951 and 1960 I was an F.B.I. Special Agent. In 1960 I was promoted as a supervisor at F.B.I. Headquarters in Washington, D.C., where I was in charge of Organized Crime and Racketeering investigations covering 26 F.B.I. Field Offices nationwide. Following the assassination of President John F. Kennedy, I was re-assigned to Special Inquiry White House Matters at F.B.I. Headquarters. In 1965 I was promoted again to Assistant Special Agent-In-Charge of Internal Security and Anti-Terrorism of the F.B.I. New Haven, Connecticut Field Office. In 1970 I was promoted to Assistant Special Agent-In-Charge of the F.B.I. Philadelphia, Pennsylvania Field Office. On July 12, 1972 I successfully negotiated with two terrorist hijackers of National Airlines Flight 496 for the release of 119 passengers at Philadelphia International Airport. In 1973 I was promoted to Chief Inspector at F.B.I. Headquarters. I also served

as Special Agent-In-Charge of the F.B.I. Memphis and Dallas Field Offices. I retired from the F.B.I. as Senior Special Agent-In-Charge of the Los Angeles Field Office of the F.B.I. with over 700 employees and a budget of over 22 million dollars in 1979.

3. I have read the Complaint in the current action of Mr. Keith Labella against F.B.I. and D.O.J. It is my professional opinion, based on information, knowledge and belief that the information sought by Mr. Labella in this F.O.I.A. suit regarding “gang stalking”, “gang stalking groups” and “gang stalking methods” reasonably describes an ongoing, active, covert nationwide program that is in effect today, and, based on my investigations and experience, has been operational since at least the early 1980’s. Since the 1980’s gang stalking has increased in scope, intensity and sophistication by adapting to new communications and surveillance technology. These programs are using the codenames Echelon Program, Carnivore System, and Tempest Systems. The Echelon Program is administered by the N.S.A. out of Fort Meade, Maryland, and monitors all email and phone calls in the world. Carnivore System is administered by the N.S.A. out of Fort Meade, Maryland, and can download any computer system without being traced or otherwise known to the owner. Tempest Systems can decipher what is on any computer screen up to a quarter of a mile away. These programs are negatively impacting thousands of Americans and severely abusing their civil rights on a daily basis.
4. Based on my investigative work, which includes intelligence from sources such as active and former members of the Intelligence Services (including the F.B.I., the C.I.A., the N.S.A. and Military Intelligence), information from informants active in criminal enterprises, and, victim testimonies, I have come to the conclusion that thousands of victims have been targeted by an illegal government rogue criminal enterprise that is active 24 hours a day within the U.S. This conspiracy is far too active to be controlled or operated by private enterprise whose goals are achieving financial gain. These operations require extensive financing with no return on the investment. This program’s operations are financed by illegal black operations, i.e., narcotics, prostitution, child

kidnapping (children sell at covert auctions for up to \$50,000 per child), human trafficking, gambling and other rackets.

5. I have documentation and know that throughout the U.S., operating 24 hours-a-day and 7 days-a-week, there is a Central Command, located within the U.S., with multiple satellite offices, whose administrators can instantly initiate surveillance, phone taps and harassment against any individual in the country. They have the technology, financing and manpower to dispense illegal surveillance and harassment against anyone at any time, day or night. I have files on numerous cases of active, programmatic, illegal government harassment currently being conducted against thousands of Americans. This makes the F.B.I.'s former COINTELPRO program, which I worked on, including in a supervisory capacity, look like a Sunday school program by comparison.
6. I firmly believe that most individuals working in the F.B.I., other intelligence agencies, and the government overall are honest, law-abiding public servants. However, a sophisticated network of rogue operatives has secretly infiltrated the F.B.I., other intelligence agencies including the C.I.A., and other key government positions. This rogue element seeks personal power and wealth and considers themselves above the law and the Constitution. They are carrying out the aforementioned surveillance and harassment activities in conjunction with organized crime, the cult movement in America including Satanic cults, other commercial and political interests, and even misguided civic organizations and neighborhood groups. This illegal surveillance and harassment program is being called gang stalking and organized stalking by the victims targeted by it. The victims are targeted for a variety of reasons including government and corporate whistleblowers, parties to financial and employment disputes, parties to marital disputes (usually divorced women), and even jilted paramours. Journalists covering controversial issues, and, even attorneys and private investigators representing unpopular clients or interests, have been targeted by this program.
7. Individuals targeted by this program have been subjected to illegal and unconstitutional phone taps, illegal re-routing of business and

private phone calls for purposes of harassment, illegal audio “bugging”, surreptitious entry into home, office, and vehicle, visual surveillance in the home conducted by illegal placement of miniature remote, wireless cameras (often accessible via internet), illegal internet spyware, illegal GPS tracking (often through their own mobile phones), regular fixed and mobile surveillance, mail misdirection, mail theft and tampering, financial and employment sabotage, slander campaigns and community ostracizing, internet disinformation and smear campaigns, poisoning, assaults and murder, illegal set-ups on drug charges and other felony charges, amongst many other civil rights abuses.

8. In addition to high-ranking members of the F.B.I., other intelligence services, and the government overall, wealthy, powerful members of criminal syndicates, multi-millionaires and the corporate elite are using the government gang stalking program to harass enemies. They can get a targeted individual harassed for the rest of that individual’s life (individual cases of gang stalking lasting for over a decade are common). The higher status members of the gang stalking conspiracy initiate the gang stalking and coordinate logistics and funding. Lower echelon government rogue operatives, lower ranking members of the military (in violation of Posse Comitatus), petty criminals and street thugs perform the actual grunt work of daily monitoring and harassment of individuals targeted by the program.
9. Based on my professional experience, extensive intelligence information and belief, it is my professional opinion that the F.B.I. is involved in and has investigative files on the subject of gang stalking, related gang stalking methods, and gang stalking groups in the F.B.I.’s vast intelligence files, that are responsive to Mr. Labella’s F.O.I.A. Complaint. Furthermore, I have personally referred numerous victims of gang stalking to the appropriate agents at the F.B.I. for investigation of their cases. I have also furnished the F.B.I. with documentation of an active, international child kidnapping ring probably operated by rogue C.I.A. agents. The F.B.I. has ignored my requests to investigate even though it is their responsibility to investigate kidnappings. I have a contact in Germany who advises me that the C.I.A. has set up secret operations on U.S. military bases for the kidnapping, sale and

trafficking of children worldwide. The F.B.I. may be using a unique codename and nomenclature for the gang stalking phenomenon in its records. However, this is a semantic difference, and, in no way changes my professional opinion that the F.B.I. has investigative files on the nationwide phenomenon of gang stalking described in reasonable and specific detail in Mr. Labella's F.O.I.A. Complaint. These F.B.I. files contain information responsive to Mr. Labella's F.O.I.A. Complaint regarding the subject of gang stalking. The F.B.I. and other intelligence agencies are administering and covering up the rogue, covert, government criminal enterprise of gang stalking. The gang stalking phenomenon appears in the records of both the F.B.I. and the N.S.A. in their records pertaining to the Echelon Program, Carnivore System, and Tempest Systems. In addition, the gang stalking phenomenon appears in the records of both the F.B.I. and the N.S.A. in their records pertaining to information collected by Narus systems. Narus is a wholly owned subsidiary of defense contractor Boeing that produces sophisticated, mass surveillance computer systems currently being used by both the F.B.I. and the N.S.A.





0:01 ... When I wrote the book and I kind of did my own searches and talked to some connections that I had within the CIA and just to verify exactly how this technology works, they wouldn't go as far as admitting putting voices in heads. They had no problem admitting the directed-energy capability

0:58 ... the only way out of it so because everybody's looking for ways to **shield** themselves and things like that and the bottom line is we're gonna need **socio-political change probably to do anything about it ...**

2:07 ... lieutenant in charge had been a patient of mine ... He told me straight out he said if I heard this story from anybody else I think they're crazy, but you had my life in your hands asleep on the table for surgery - I do anesthesia. And he said but you know coming from you and your stories never changed ... So they kinda they went through ICE and tried to see if any of this video, if they were videoing any of the sexual assaults and putting them anywhere. And basically ... it's **like this group of this former FBI guy is allowed to do it** ... Which is like what I kind of wondered all along is, you know, if I went following people around and tampering with their cars and standing around their front doors, you know I'd be arrested pretty quickly. And these guys were so brazen this wasn't surveillance from afar or I kind of think that cars following me, or I kind of think that person's following me. These were people literally standing in front of our windows, right until you would come walking down the sidewalk and they would run and jump in a car. Or three cars following me, moving jockeying around at 2:00 in the morning on a weekday you know in coming home from her house and shooting the finger at me when they would drive by. Or trying to block me in until I'd finally maneuver my way around and you know that only good thing about being in Texas is what ended the **stalking** was when the sheriff came out to my house and said you know what, you live in a rural area and if it's nighttime and they're on your property, shoot em. And this was not there was not anything that was questionable about what was going on ...

4:15 Why don't you just start by explaining what the problem is as you see it, and the ways in which classified technologies are being used on targeted persons ...

Well, from my experience it seems to be a form of **remote neural monitoring** is one of the terms we use for it. The other term is **psychotronic weaponry**, weaponry that has been designed to interact with the human nervous system in order to remotely pick up on someone's neural network or EEG and not only receive that and monitor it but manipulate it and place it back into the victim to control their emotions or control their actions or bodily functions for that matter. The other more recent term we have for that is EEG heterodyning or EEG cloning ...

5:55 ... I wish I could give you a good example of how it works. I know Robert Duncan worked on some of the projects. He claims it's a very complex you know mathematical situation that does it.

6:05 ...The bottom line though at least from what I've been told is that it's mostly based on **Robert Malik's patent of remote neural monitoring** in which he found that if you shoot two dissimilar frequencies into the human brain that the human brain will actually create an interference frequency as it tries to duplicate the two dissimilar frequencies and the interference frequency that gets transmitted back out of your brain can be decoded and your EEG digitally manipulated out of that. Now and that patent came out in like 1974 it was a Malech Robert Malech. And it was **actually invented as a way to monitor pilots**. That way if you had a pilot that was falling asleep or a pilot that was starting to hallucinate, they could see that remotely and then stimulate the pilot to wake him up or to bring him out of a delusion, especially fighter pilots that are on you know continuously long missions. It appears to be mostly being done in that way. Now one of the more scary things that's come to light lately is the way the NSA is monitoring our computer systems and they're doing that with continuous wave radar CWR ... Lately there's been a program of interdiction where you know the computers and smartphones and things are actually gotten before they actually reach our shores for sale and are being implanted with a particular type of implant. One of them is called a cottonmouth, at least four pcs, and that's a small chip that actually goes into the cord between the computer and the monitor. And when that chip is hit with continuous wave radar it will begin to transmit up to eight kilometers away whatever data is being sent from your computer to your screen. It may be monitored in real time or it may just be data that's collected you know automatically without anybody actually watching it. But one of the thoughts that we have is that it might be continuous wave radar being used on humans as well. And if you see Jacob Appelbaum, some of his speeches and reports and an exposure on this, he kind of alludes to some of Snowden's releases that the same technology that they're using on computers they may be actually using on human systems as well ...

9:32 ... One thing that we found a long time ago within a lot of the neurologic studies is if you bombard the brain long enough with a certain frequency the brain receives that frequency and adapts to that frequency and begins to operate in that frequency. Specifically with Malik's patent, if you're using two dissimilar frequencies and you get one hemisphere of the brain operating at one frequency, the other hemisphere at a different frequency, they create an interference frequency. We know the brain transmits that's why we can actually look at an EEG. Now traditionally in medicine you know we're using it with leads on the scalp and that was the whole point of his patent, is that **you no longer actually had to have leads on the scalp, that it could be done remotely, with radiofrequency. Now that's not in sum the total of what these victims are experiencing that's the monitoring and maybe some of the emotion manipulation.** Also, you can

control the brain and making the body twitch or making the body do just about anything since everything's controlled by the brain. But there also seems to be a directed-energy component to the victimization of these people because most of them are also complaining you know eye burning, skin burning, and what would appear to be microwave energy-based weapons. Body heating. Most of those techniques used for sleep deprivation. Almost all of the victims that I've spoken to complain that the attacks seemed to be worse at night and seemed to be geared at actually sleep depriving them ... Directed energy weapons have been worked on for some time and if you look at the Addendum the Army's addendum to the technology of non-lethal weaponry that came out late 80s, they clearly talk about using direct microwave energy as a weapon. You know we're already seeing that and the active denial system, millimeter wave system, silent guardian, which is a joystick controlled a millimeter wave weapon that is actually being used experimentally in at least one Los Angeles prison.

11:48 When prisoners get out of line a **guard can actually manipulate the beam and burn the person** until they get out of the way of the beam. So that's been worked on you know for some time. Now how it's being delivered **possibly via satellite or being delivered long range is classified technology** that you know hopefully will eventually get somebody that's a whistleblower to tell us more about how that's done. From what I've been told by some of my contacts that **a lot of this is being done, especially the weaponry, by satellite.** There's been other you know world leaders you know that have complained about hearing voices and being attacked with directed energy. Of course most of these victims that complain about it or immediately sent to a psychiatrist who won't Google anything or won't look at any other research. But **the directed energy component is has been around for quite a while, How it's being used on such a grand scale is yet to be seen...**

13:32I think most of what we're dealing with in the victim population is probably **satellite based or something much more remote** than that. I know in my personal studies I've actually taken victims onto a ranch here in Texas where there's no power lines, there's no cell towers, you can do RF scans on the property and see that it's pretty clear, and these victims still hear voices, they still get attacked. I've done the same thing by taking victims in a boat into the Gulf of Mexico to escape the possibility of it being handheld weapons or neighbors - **they still hear voices, they still get attacked.** ...Some of the victims I've talked to they're probably a little better explaining their situation, have even got on planes and flown to other countries. I had **one victim who's pretty well-off financially that actually flew to Cuba to try to get away from this and was still hearing voices and still being attacked even in Cuba.** Just so you know, these are all people that you know were professionals, were educated, were functioning in society just fine, and most of them were between 30 and 40 when **they first started getting victimized.** Much older than you would typically see somebody all of a sudden come down with schizophrenia and no reason to have all of a sudden developed an acute delusional disorder ... Most of them were functioning, most of them

are professionals. I've talked to a lot of doctors, a lot of lawyers, whistleblowers from the Natl Geospatial Agency, a couple of whistleblowers I've worked with from the NSA. These were functioning people and **they can tell you the day they started hearing voices and started experiencing attack and typically it's in the 40s, late 30s early 40s,** with no history of mental illness and high functioning in society prior to that day ...

16:26 ... many of them are placed on medications meant for schizophrenia or for delusional disorder and so they're stuck on these medications and they're still being attacked and they're still hearing voices. The symptoms won't subside with traditional psychiatric treatment ...

19:39 ... It's truly **organized stalking** ... You'll notice people unknown to you. These aren't people hired by a loved one or anything, traditionally, or not an ex-boyfriend or ex-girlfriend. But all of a sudden you notice the same vehicles following you everywhere you go. People standing around your front door. Standing around work. Creating scenes and grocery stores around you where you know they may be talking to someone else you know within earshot of you but talking about something you did or something you said to a loved one. And it's geared to let you know that there are people that know your lifestyle and know the specifics of your lifestyle ...

20:57 ... I think this is **probably being done by private investigators**. However, its private investigators usually **with former CIA or former FBI experience**. And which is why they're being allowed to access the technology. At least in in the case here in San Antonio it was the PI group that we identified here. It was a former FBI fraud investigator that opened up his own private investigative agency after he retired. He hired nothing but his family members and pretty much advertises corporate espionage and as the guy you turn to if you want to harass an ex-wife during a divorce proceeding to make her look crazy, possibly to get out of paying child support or get custody or kids or to get out of paying alimony. Other than getting you down that pathway to a psychiatrist and putting in you a victim mind-set I think the other function of the organized stalking is to GPS you by vicinity. While we will find radio transmissions either emanating into or from the victim, when you image those sites, we're not typically finding chips. Which leads me to believe that most of this is probably being done without any type of an implant.** Well the way you would do that in my mind would be to stalk that person and GPS then by vicinity until you can use whatever technology that is being used to **remotely track them you know by their EEG**. There's other ways to remotely track someone by body imaging by facial recognition. I've heard some of the people talk about now DNA resonance, which using continuous wave radar if you

bombard the human body with it we all have a different DNA signature, and that that can actually resonate and be received

26:38 ... Why them? Why you for example? Well in my case in the book the girl that I was engaged to had kind of attracted the fancy of a **an older ear nose and throat surgeon in San Antonio who had told me several years ago that he had this former FBI guy that he referred to as the ghost that did this barely legal ...**

28:05 I started following those vehicles writing down the plate numbers they all came back to this PI agency that he had told me about several years prior that he used to harass competitors corporate espionage type of stuff. Now once you know they got their hand slapped at the Rockefeller Commission you know a lot of information came out of freedom of information and there's been some really good books written on MKULTRA based on what the government released in freedom of information. Their job was to find out if any non-consensual experimentation funded by the government was still ongoing in our country or abroad. There were four meetings. At each one of those meetings there were well over a hundred people in the public forum. **Almost all of the people in the public forum and work forum were complaining of electronic harassment, directed-energy attack, and hearing voices. Unfortunately the people he appointed to the actual board to hear it were mostly apologist bioethicists from Harvard and Yale.** I was the only person that actually got up there and pointed out the loopholes in the common rule that allows for non-consensual experimentation. 



DREAMS AND MEMORIES FROM YEARS PAST CAN BE ACCESSED. CAPTIVES CAN BE ASSAULTED (IT IS ALL RAPE) ALSO WITH FALSE IMAGERY AS DREAMS DURING SLEEP. CAPTORS CONTROL THE SLEEP CYCLE AND SOME CAPTIVES GET VERY LITTLE SLEEP, ANOTHER LIFE-THREATENING GOAL OF CAPTIVITY. CAPTORS CAN INSERT THOUGHTS AS WELL AS DETERMINE WORDS THE CAPTIVE SPEAKS.

EMOTIONS, CONTROLLED BY THE BRAIN, CAN ALSO BE ALTERED. PEOPLE CAN BE MADE ARTIFICIALLY DEPRESSED AND SUICIDAL, OR THE OPPOSITE. THIS CAN CAUSE PEOPLE TO KILL THEMSELVES.
