Jason Fowler advised that as of 5:00 p.m. there were no emails with public comment and there were no members of the public on the conference call. No members of the public were physically in attendance, however, Bob Skidmore of Shodeen, Inc. joined the meeting via telephone at 7:12 p.m.

Mr. Fowler, representing the District's operating engineer did not find that the methodologies for calculating capacity provided by Shodeen were viable or consistent with the District's historic standard (12 month average flows). The Board agreed with the operating engineer's recommendation to continue the practice in place for determining capacity.
