City Council Minutes

March 4<sup>th</sup>, 2019

The City Council of the City of New Munich met in regular session at 6:30 p.m., in the City Hall. Jim Poepping, Ron Doll, Shawn Duevel and Elmer Boecker were present. Pat Nathe was absent.

On a motion by Ron Doll, seconded by Elmer Boecker and carried the minutes from February 4<sup>th</sup>, 2019 were approved.

Fire Chief, Allen Fiedler was present to inform the Council on three medical calls last month. He mentioned 2 fire members were going through the 1<sup>st</sup> responder initial training this month. Currently the Fire Department is at 18 members but still looking for more members. Allen didn't have any bills to be paid. Al would like to Thank everyone for helping keep the fire hydrants free of snow this season.

Water/WasteWater Operator, Tom Valerius stated he took water samples from New Munich Meats and all samples looked good. We had 2 water lines freeze in town, one resident and one business. Tom Valerius spoke with Tom Hoppe from Oak Electric regarding the well house, we will be getting a quote regarding this repair from when the hydrants were flushed and breaker kept kicking out. The inspector came out to look at it and he gave us the okay to change out from 100amp to 200 amp if necessary. Tom will be taking more water samples from the ponds this month and he would like some snow removed by the ponds so he can get to them.

On a motion by Ron Doll, seconded by Elmer Boecker and carried the building permit for Scott and Tina Johnson, was approved.

On a motion by Ron Doll, seconded by Shawn Duevel and carried the Resolution 3-19-A Gambling Permit for the Immaculate Conception Church.
