Friends of the Sherrard Public Library Group: The Director will send a letter to the Friends Group requesting that they attend the February meeting so that we can discuss what needs to be done to get the group active and compliant with nonprofit status. Book Mobile: The Director has made contact with the Clinton Auto Auction to ensure all the paperwork necessary for sale is in order before the Book Mobile is driven up to Clinton.

Sidewalks: Still waiting to hear from the village about sidewalks. Received a bid from Laverdiere for sidewalks and discussed taking additional bids.

New Business:

Molly Kindelsperger was appointed to sign contracts and other paperwork in President Holdsworth's absence.

Amendment was made to the Bylaws to reflect a change from two consecutive two year terms to three consecutive two year terms. in Article B, paragraph 1.1 concerning how long a President may hold office.

Rev Tom Wright's proposal to act as the tax-exempt agent for a possible Roy J. Carver Museum and Library were tabled for future conversation until after the new library is built, as we have asked the Carver Foundation for funding for a new Computer and Technology Lab.
