## **Two More Arrests and Murder Charges Filed**

Three men were arrested in the kidnapping and murder of Melody Hoffman, age 20, Marion whose body was discovered Sunday, Feb. 18 at the Lily Lake picnic area.

McKinley Louisma, 23, of Hiawatha, was arrested Tuesday, Feb. 20 and has been charged with 1st degree murder and kidnapping.

Dakota Van Patten, 18, of Cedar Rapids, was arrested Wednesday, Feb. 21, and has been charged with 1st degree murder, kidnapping and conspiracy to commit a forcible felony in the death of Melody Hoffman.

Then Thursday afternoon Marion City Police announced that Logan Kimpton, 18, of Hiawatha was arrested and charged with conspiracy to commit forcible felony, assault with injury and willful injury. He was not charged with murder.

Tuesday, Feb. 20 a law enforcement media release accompanied by the Linn County attorney's affidavit reported that there were two people involved. It announced that Louisma had been arrested and was being held. Wednesday, Feb. 21, the Linn County Attorney confirmed that Dakota Van Patten as the second suspect. Evidence was found linking Van Patten to the case.

Louisma admitted to investigators that he and Van Patten were with Hoffman. He said that Van Patten bound Hoffman with duct tape and put her in Louisma's car at Morgan Creek Park in Linn County. He said the pair transported her to several locations. Investigators determined that she was at Morgan Creek Park when her Apple watch recorded her heartbeat intensify before it either stopped or was

#### Homestead Folk Art Museum to Open

The former Homestead General Store is being transformed this winter by the Amana Heritage Museum team. With hard work and creativity, it will become the Homestead Folk Art Museum to open in the autumn.

Not only will it be a place for exhibiting folk art and fine art created during Amana's communal era and throughout the post-communal (post 1932) period, it will, in future, be a place where workshops can take place in partnership with the Amana Arts Guild and local artists. It will be open to the public and admission will be incorporated into the multi-site museum ticket price. The official opening will be November 1, 2024.

Jon Childers, Amana Heritage Society executive director explained that the opportunity came up last year to create this new site.

The Heritage Society Board of Directors working with the Arts Guild Board of Directors identified ways that collaborative events and workshops could take place there. Furthermore, it's important to have a large, accessible space to exhibit art and folk art created in Amana.

The building has a kitchen suitable for cooking classes, open space for classes, plus first and second floor exhibit and storage space.

Childers explained, "The interpretation of Amana's folk art culture includes dozens of trades brought from Germany to America and practiced during the communal era (1855-1932) and beyond. It also includes the Prestele family whose botanical lithography prints are considered the most important nineteenth-century lithography created in America. The works of renowned Amana-born painters like Carl Flick, John Noé, William Noé, Jack Hahn, and Gordon Kellenberger have not been available for public viewing. Frank Young Sr., whose parents were both members of the communal Amana Society, founded the American Academy of Art in 1923, left an impact on the Amana community through his contact with relatives and friends." but I feel a little strange wondering if they really mean it. deactiviated.

The Iowa State Medical Examiner's opinion is that Hoffman died of strangulation. She had been beaten and stabbed.

Then on Thursday afternoon law enforcement arrested Logan Kimpton. Investigators say that he was seen on a surveillance video with one of the other suspects buying gloves and two machetes from a Walmart in Cedar Rapids.

When questioned Kimpton confirmed the purchases. The complaint says that when he was confronted by officers he was told "he chickened out" and he responded "Damn right I did."

Kimpton reportedly told three other people one or two nights before the murder, that a plan had been made to murder someone. He did not name the intended victim.

Van Patten and Louisma were accused of beating the same man in January 2024, both had been released on bond in that case, according to a news report on KCRG News.

A candlelight vigil and memorial was held for Melody Hoffman, Thursday, February 22 at Wanatee Park in Marion. Organized by friends, the event was "We want to focus on placing the Amana people in a communal context and explore how they expressed themselves through the trades, crafts, and industrialized arts (calico and woolen) traditions."

"We will bridge the gap of understanding how they created utilitarian pieces with a small degree of expression in them to having an explosion of expressive arts beginning pre-1932 to what we have today," he added.

The Amana Heritage Society has many pieces, including paintings and lithographs, in its collection that will be exhibited, as does the Amana Arts Guild,

but they are looking for specific items that help tell the story of art and craft in Amana. The plan is to reach out to the community to locate those pieces for the new museum.

Since last year the staff has been carefully inventorying the entire museum collection - that's thousands of items - a process that happens every five to 10 years. Artifacts are evaluated, cleaned, museum identification numbers and locations are checked. That process, which would have taken place regardless of the new museum, has helped staff create exhibit plans for the new Homestead museum. Exhibits are being designed with the goal of creating a comprehensive view of Amana folk art, industrial art and craft.

The Homestead store has been owned by the Amana Heritage Society for nearly 20 years and has been used for storage and at various times for museum exhibits and special events. Most recently it was leased to and operated by Die Heimat as the Nextdoor Event Center.

Now it is being refurbished for exhibit and work space. "The next steps will be a good amount of carpentry work," Childers said.

"Some of the walls require new wall covering to accommodate art, failing walls need to be repaired, and the entire first floor will be repainted. The floors will be repaired and refinished to help with color schemes in the exhibit areas. In the spring and summer, we will have brickwork done and the windows and doors repaired and painted. Over the summer, we'll begin the layout of the exhibits as we purchase the exhibit cases, exhibit walls, and art hanging systems," he said.

A grant from the Hall-Perrine Foundation helped provide for an art installation system so that art may be correctly exhibited and properly lighted. Fundraising done by the board and the ASH team will pay for repairs and restoration work at the site.

"It's pretty exciting. . . I think the opportunities for collaborating on classes and having exhibits is pretty neat. This will allow us to tell Amana's stories in ways we've not been able to do and that's really very exciting," Childers concluded.
