City Council Minutes

January 6th, 2020

The City Council of the City of New Munich met in regular session at 6:30p.m., in the City Hall. Jim Poepping, Shawn Duevel, Elmer Boecker and Ron Doll were present. Pat Nathe was absent.

On a motion by Ron Doll, seconded by Elmer Boecker and carried the minutes from December 2nd, 2019 were approved.

Fire Chief, Al Fiedler was present to inform the Council of 1 medical calls.

He stated they purchased a used fire truck, hoping to pick it up this week and start training on it. He will post the old truck to sell locally. He presented the following bills to be paid: Alex Air \$631.93 & \$3,703.46, Stearns County Fire Chiefs Association \$15.00, Everything Signs \$24.00, Custom Fire Rescue Training \$1,000.

Waste /Water Operator, Tom Valerius was present to inform the Council of the pump to the lift station was not running right(run times were high), Roger Boecker came to repair it. Ponds are a little higher than normal but we have had a lot of moisture in the air the last month. Tom will keep an eye on it. The electrical inspector was at the pump house with Oak Electric and inspection went good as far as we know.

After some changes made by the Jaycee's, the agreement between New Munich Jaycee's and City of New Munich was approved, on a motion by Ron Doll and seconded by Shawn Duevel. All in favor. Jaycee Members were Sandy Zierden, Ann Piotrowski and Bobbie Loch were present.
