FLORIDA

The Florida Territory became a state in 1845, and was organized as a single-district.¹ Two years later it was divided into Northern and Southern Districts with one judge apiece.² In 1962 Congress created the Middle District by transferring three judgeships at the time assigned to the Southern District.³ Florida was assigned to the Fifth Circuit from the inception of the modern appellate court system in 1891 until its transfer to the new Eleventh Circuit in 1980.⁴

FL.ND.01 was the original seat (see Judge Bronson's line of succession), and served the entire state until its reorganization into Northern and Southern Districts in 1847. Congress created an additional temporary seat, FL.NSD.01.01, to serve both districts.⁵ The occupant of this position would be transferred to either the Northern or Southern District following the first vacancy on either court. This occurred with the retirement of Judge Long (FL.ND.01.07) in 1947, at which point Judge DeVane was transferred to the Northern District. DeVane's predecessor, Judge Curtiss Waller (FL.NSD.01.01), was the original appointee to the transient position, and always served as a roving judge until his elevation to the Fifth Circuit in 1943. As such, his position really never was housed in a statutorily-created district.⁶

In creating the Middle District, FL.SD.01, 03 and 04 became FL.MD.01 through 03, respectively. Judge Whitehurst's (FL.MD.04.01) line was created to serve the Northern and Southern Districts.⁷ Judge Young succeeded him in 1961. One year later the Middle District was added to this roving position,⁸ and it stayed this way jurisdictionally until it was transferred to the Middle District exclusively in 1966.⁹

FL.SD.02 was created in 1922, and by that act the seat was abolished upon the departure of its first and sole occupant, Judge Lake Jones.¹⁰

FL.SD.22 was authorized as a temporary judgeship,¹¹ with the stipulation that the first vacancy on the court occurring ten or more years after the confirmation of the initial occupant will not be filled.

Florida has thirty-seven judgeships, distributed as follows: fifteen in the Middle District, four in the Northern District, and eighteen (counting the temporary) in the Southern District.
